NURS 641 Leadership Role for Informatics Nurse Specialists

COURSE DESCRIPTION:

This course is specifically designed for nursing graduate students who are pursuing the informatics nurse specialist (INS) role. In this course, students will learn how to lead the implementation and optimization of health care information systems that directly impact nursing and positive patient outcomes.

3 credits (3+0) 3 lecture hours / week = 45 hours / semester

Pre-requisite: All 500 level courses

COURSE OUTCOMES:

1. Use decision-making support processes that affect patients, administrators, and practitioners in health care settings. (Health care environment)
2. Evaluate the design and effectiveness of informatics solutions and technology to improve the provision of care, administrative processes, decision-support systems, research, and education. (Scholarship for practice)
3. Synthesize the knowledge of the building blocks of nursing informatics (i.e., nursing science, information science, computer science, and the ethical management of information) that will guide the nurse working with health care information systems. (Theoretical base for practice)
4. Appraise the role of the INS through the exploration of nursing informatics practice related to health care technologies supporting the collection and dissemination of health care information. (Specialty leadership role practice)
5. Analyze the hardware and software infrastructure necessary to improve practice while safeguarding privacy and security of data. (Health Care Environment)

This is a fully on-line course.
