Occasionally, changes occur in a student's personal life that may warrant re-evaluation of their financial aid eligibility. If these changes have resulted in <u>a significant reduction of your total family income since 2022</u>, you may submit a Request for Special Consideration. The most common examples of circumstances that may warrant reconsideration have been listed within this form. Please note that filing a Special Circumstances Request does not guarantee that the student will be awarded additional financial aid. <u>At best, Special Circumstances Requests may result in the student receiving the maximum subsidized loan and/or Pell Grant</u>.

Prior to making changes to your FAFSA, federal regulations require that the Office of Scholarships and Financial Aid must first verify that your initial FAFSA was filed correctly through a process called verification. <u>Your Special Circumstances Request will not be</u> <u>processed until after the verification process is complete</u>.

To complete the verification process, you must:

- Complete and submit the 2024-2025 Dependent Verification form and provide 2022 tax documentation as listed in the tax documentation section of the form.
- Complete and submit the 2024-2025 Special Circumstances Form, along with a signed, detailed letter from your parent(s) explaining the reason for the request.
- Provide current income information: If your Special Circumstances Request is approved, the Office of Scholarships and Financial Aid must provide FAFSA with accurate income information from all sources. The type of documentation may vary, depending on the time of the year that the change occurred. For example, if a parent lost his or her job in December, 2022 and has not regained employment, the parent's 2023 federal tax return would accurately reflect the reduction of income. A copy of that tax return could be provided to show current income. If the job loss occurred in 2023 or 2024, the most recent (or final) pay stubs, with year-to-date totals for both parents, along with unemployment benefit statements for the unemployed parent would allow us to calculate estimated income for 2023 or 2024.

DO NOT submit a Special Circumstances Request if any of the following circumstances apply to you:

- The total family income for 2023 or 2024 will be more than it was in 2022.
- You have not filed a FAFSA for 2024-2025.
- Your Student Aid Index (SAI) is either zero or a negative number, as indicated on your Student Aid Report from FAFSA.
- Your total family income has NOT been reduced.
- The change of circumstance is based solely on increased debt or filing bankruptcy proceedings.
