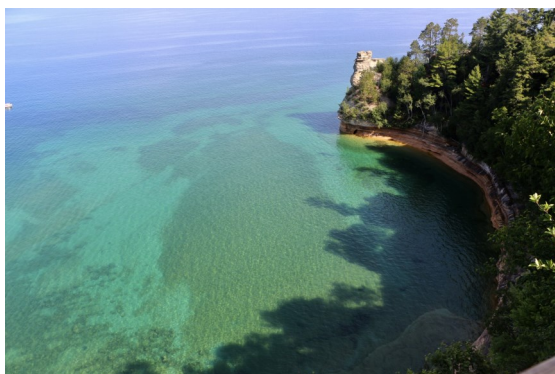

President's Post



Happy springtime to all of you. I am writing this in the early part of February so I am unsure how the spring season will be this year. We have just had the warmest December and January in recorded history. This probably has made some people very happy, but our tourist economy here in northern Michigan depends upon reliable cold weather activities such as skiing, snowshoeing, snowmobiling, and ice fishing. Many popular local activities like Houghton Lake's "Tip Up Town" and Traverse City's "VASA race" have been drastically curtailed or completely cancelled due to the warm weather. Also, many people depend upon snow removal for their livelihoods in the winter. Is this the new normal? Will Michigan cease to be a "water/winter wonderland?" Weather forecasts now con-

tain words that I was unfamiliar with just a few years ago: Bomb cyclone; atmospheric river; polar vortex. It seems that California is either on fire or experiencing drastic flooding. We are having tornados in December now in places like Kentucky instead of in March in Oklahoma. We spent last summer breathing in smoke from Canadian wild fires. Last summer, the southwestern states had days on end near or exceeding triple digit temperatures. Are we experiencing climate change? I do not know but we are certainly experiencing global warming. Even though we are warmer in the winter now and losing snow cover, we have been spared the most devastating effects (droughts, fires, frequent tornados and floods) of the global warming phenomenon. Michigan has been losing population for the past couple of decades, but I think our population will start increasing again soon because we have plenty of the most valuable resource on the planet: clean, fresh water. This is a great place to live and we are blessed to be here,

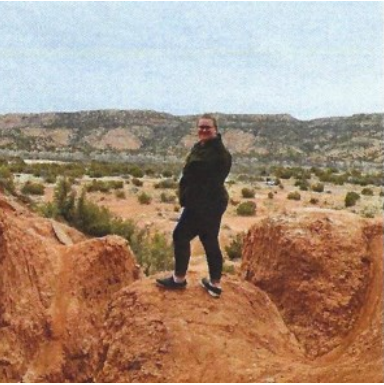


Jessica Miller

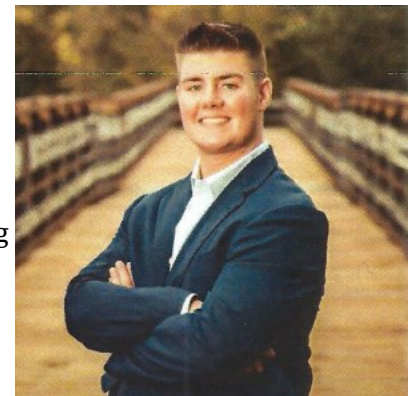


Hunter Bartlett

Proposed Amendment to FSUEA Bylaws

In keeping with the need to provide for flexible meeting opportunities, including the use of technology to accommodate Directors who may reside at greater distances, or be out of town at meeting times, the Board proposes the following amendment to the Bylaws. Changes are highlighted in **red font**. (and ***italicized*** for those reading black and white printed copies)

ARTICLE III - Meetings/Quorum—Section 2 Board of Directors Meetings

The Board of Directors shall hold a minimum of four (4) ***scheduled*** meetings per year. These ***scheduled meetings may be in-person and/or electronically mediated***. The president may call additional ***special-purpose*** meetings at his/her discretion or shall call a meeting upon the written ***or electronic*** request of three (3) or more Board of Directors members. ***These additional meetings may be entirely electronically mediated (email, text, or computerized)***. A quorum at ***all*** Board of Directors meetings shall be a majority of the Board of Directors members.
