





1. Proposal Summary

Third-year foreign languages courses at American universities are traditionally taught in the target language; by continuing teaching our three Hispanic culture courses in English, with no Spanish competence requirement, we will not be complying with national norms. Back in 1988, when I proposed SPAN 331 as a regular course offering in our department, I did not include previous knowledge of Spanish as a pre-requisite because we wanted to attract students from across campus in the hope of making our Spanish program grow. Our program has grown considerably. Back in 1988, Manuel Puerta and I ran the whole program; today we are three full-time professors and two full-time adjunct instructors. We have had 25 students with a Spanish minor or Spanish Ed. minor graduating between Fall 2001 and Summer 2006. We currently have 60 (sixty) students who have declared a Spanish minor or a Spanish Ed. minor (a number growing almost daily). I have no concern that these numbers will be affected adversely by the proposed change; in fact, many of my 28 students requested that my SPAN 332 (Spring 2006) be taught in Spanish. Also, because of the recent implementation of the two-year foreign language requirement for high school graduates, it would be reasonable to suppose that future students entering Spanish classes at Ferris will enter with higher skill levels in Spanish and with higher expectations to build on their competency. Furthermore, Lisa Ing believes this new high school requirement will increase the demand for Spanish Ed. majors and minors statewide.
