1. Proposal Summary

Music in Film is intended to be a survey course for students of all majors who wish to understand the background and historical development of music in the Cinema. It is designed to help the student comprehend the relationship between music soundtracks and the enjoyment of film. Emphasis will be placed on viewing and discussing films and soundtracks from the silent era chronologically through to the most current influential 21st century films. Students will understand the degree to which music can enhance the film-going experience. They will be able to recognize music that is highly effective as well as music that does not seem to convey the correct atmosphere for the action on screen. They will recognize periods and film eras through different musical genres and styles. They will be able to apply what they have learned to their ongoing cinema experiences.

Film music is increasingly gaining respect and recognition from the academic community. Composer Peter Odegard in *The New Oxford History of Music* states, "It (film music) is in fact the most widely dispersed repertoire being played today, and hence, in its peculiar way, the most influential." For an increasing number of Americans film music is the new classical orchestral music of our time. Film scores written by composers like John Williams, Danny Elfman, John Barry and Hans Zimmer are regularly performed in the repertoire of orchestras and bands throughout America. Soundtrack music from films such as *Jaws*, *Star Wars* and *Rocky* are more easily recognized by Americans than the music of most of the classical masters. From the first experiments with sound in films such as Al Jolson's 1926 classic *The Jazz Singer*, film music has had a dramatic affect on American culture. The soundtrack album from *Saturday Night Fever* pushed disco into the mainstream of popular music and went over thirty times platinum (selling over 30,000,000 albums) shattering the previous record.

The study and appreciation of film music has also grown since 1977 because of the increasing number of sales and rentals of VCR tapes, DVD's, soundtrack recordings, and because of the availability of internet music and films. This course will add knowledge and understanding to enhance the student's cinema experience. It is designed to complement traditional music appreciation for the general education student, and will provide valuable information for students in the Music Industry Management program.

The course will be divided into seven segments:

- I Music in Film Background (weeks 1-2)
- II Silent Film Era and live theater music (weeks 3-4)
- III The Sound Era Begins (weeks 4-5)
- IV Decline of the Hollywood Studio System 1944-59 (weeks 6-7)
- V New American Cinema 1960-76 (weeks 8-9)
- VI The Classic Revival 1977-88 (weeks 10-11)
- VII Into The New Millennium 1989 - (weeks 12-15)

Students will also be required to investigate, analyze and discuss film soundtracks and their effectiveness. They will each select, research and present to the class the important musical highlights from a film of his/her choice for discussion.
