General Summary

As of May 29, 1975 (working day 105) working drawings are still being prepared by the tenant. Once these are available, the required permits will be obtained and construction of foundations will begin.

It is hoped to start field work on Monroe, wisconsin by June 19, 1975 (working day 120). The structural building frame and other components will be delivered to the site on July 7, 1975 (working day 131) with erection due to start on July 9, 1975 (working day 133). The target turnover date for the main sales area and some of the service areas is September 17, 1975 (working day 182). By the target turnover date, enough of the service, stock, lounge, rear effice and TBA areas must be available so that fixturing can start. Completion of these sections of the building, however, is projected at one week later than the turnover at September 24, 1975 (working day 187).

General Summary

As of July 25, 1975 (working day 145) the project is from 3 to 10 working days ahead of Issue #1 late start/late finish dates. Structural steel is substantially erected and plumbed, wall panels are presently in work and about 40% of the floor slab on grade is constructed.

Presently the most critical area of the job appears to be in the TBA area. In-slab tenant work will begin on Monday, July 28, 1975 (working day 146). The scheduled late start date was August 1, 1975 (working day 150).

As part of our monitoring, we diagrammed the site work and this drawing, sheet #1 (Issue 1A dated July 25, 1975) was distributed, one copy to Mr. Henstedt,

one copy to Mr. Goyette and three copies to Mr. Mowry.

It is expected to resume work on the site August 1, 1975 (working day 150). To start this work it will be necessary to move some metal deck, ventilators and general materials stockpiled on the site. It will take about 6 to 7 working days to get the site ready for placing the stone sub-base and work should proceed on out as rapidly as possible so that the site is completed no later than September 15, 1975 (working day 180).

In general, the project is in reasonably good shape, being from 4 to 10 working days ahead of the current late start/late finish target dates. TBA area and site work will be critical and I recommend that heavy attention be given both of these areas immediately. Also, a check should be run to see if there are any outstanding easements or permits that must be cleared for starting site work.
