General summary:

As of January 23, 1997 (wd 526) the foundations and the superstructure of the building have been completed and the structure is being closed in. Roofing is about 30% complete and if the weather remains good roofing should be completed to horizontal dry in by early next week.

Forms have been stripped at all floors and the basement, 1st and 2nd floors are clear of reshoring. The third floor is also clear and as the roofing is completed spray on fireproofing will be applied to the beams and roof deck.

Procurement of material and equipment to date has proceeded well. However recent revisions to hollow metal frame configurations may delay fabrication and delivery of many frames needed for doors in stud walls. Mr. McGowan is working closely with the architect and the owner to expedite design, detailing, approval, and fabrication of these frames.

We did not do a detailed analysis of procurement status but some of the more critical delivery information is summarized below.

- Electrical mock up - delivery on January 30, 1997
- Lay light mock up - has been delivered to project
- Skylight frame and glass - to be delivered February 14, 1997 (wd 542)
- Steel stairs being fabricated - on job about February 5, 1997
- Package 3 hollow metal frames to be delivered January 28, 1997
- Package 5 hollow metal frames delivery to be determined
- Curtain wall delivery - last week in February, 1997
- Curtain wall glass not selected yet

No major close out is in work at present. However as the need for a partial certificate of substantial completion for an area and a partial certificate of occupancy is required some close out procedures must be implemented. I have furnished Mr. McGowan a check list of major close out activities. I strongly suggest the project team put these into a format tailored to the project and use the list as various areas are occupied. Another important close out element particularly in phased turnovers is the start of the equipment warranty periods. These should be set as the punch out proceeds.

General

As the project moves into interior rough and finish work I recommend careful monitoring of the job be done on a regular basis by the project team. As deviations from the issue #3 plan are encountered, consideration should be given to updating the plan of work. I shall check periodically with Mr. McGowan and Mr. Styrlund to see what is required by the job progress being made.

A brief summary of the status of the various building areas is given below.

Basement

Electrical and mechanical rough above floor work is substantially complete except for fire protection piping. Sprinkler piping installation is expected to start the week of March 10, 1997

(wd 558). We have not prepared a network model for the basement work; however Mr. McGowan and I will review the need for a basement plan of work at our next monitoring session. The main use of the basement space is to provide the owner space to store facilities maintenance materials. No target end date for basement work has been set other than the project end date currently in effect.

1st Floor

Rough mechanical and electrical work at the first floor is substantially complete; metal studs and in wall work is about 85% complete; and hanging, taping, and sanding dry wall surfaces is just starting.

The lag at the first floor over late starts and late finishes is currently about 24 working days. This lag has been due, in part, to the later than expected delivery of curtain wall framing. Also, delivery of door frames was slowed by design modifications to the hollow metal frames and a consequent slowing of the delivery. The target completion date of March 31, 1997 (wd 574) is an important milestone due to the need to start as early as possible on existing building remodeling. Completion of the first floor will allow moves to be made from the existing buildings to newly constructed office space in the infill area.

Because of the critical nature of this turnover, Mr. McGowan and I made a full update of sheet #3 to issue #5, dated March 5, 1997 (wd 555). The replanned compression of time assumes a continuous flow of needed materials and equipment being maintained to the job site. In the new issue we compressed some of the more critical activities and simulated several courses of action. This updated model shows a completion of the space on the evening of March 31, 1997 (wd 574).

Museum shop remodeling is proceeding well and all major activities are meeting targets between early and late starts and finishes. Dry wall installation is well along and production taping and sanding is to begin shortly.

At the skylight area the skylight frame and glass is fabricated and on the job. Erection of the skylight system is about 40% complete. The lag in installation is approximately 10 working days. However the project team has been able to proceed with some work that was planned to follow completion of the skylight. This has reduced the current lag to about 2 working days. In our updating of the 1st floor work we were able to maintain key target dates.

2nd Floor

Above floor rough mechanical and electrical work at the infilling is substantially complete and installation of metal studs, in wall work and dry wall is in progress. Taping and sanding is about to begin at the second floor. All major activities are meeting dates between early and late starts and finishes.

The owner has started moving second floor exhibits to free up the South Asia gallery for remodeling. Work is expected to start on March 31, 1997 (wd 573). The owner is also moving out of storage area 26 to allow remodeling work at the existing building to begin about March 17, 1997.

3rd Floor

Most above floor rough mechanical and electrical work has been completed at the infill, and installation of metal studs and in wall work is proceeding well. Major activities are currently meeting targets between early and late starts and finishes. Work at the Bean Gallery is due to begin in mid April, 1997, and at the existing building in early July, 1997.

General

The project is currently in fair condition with the first floor infill work having to be compressed to meet the critical completion date of the P.M. of March 31, 1997 (wd 574). Other areas of the building are generally meeting key early and late starts and finishes.

I shall be in touch with Mr. Styrlund and Mr. McGowan shortly to set the next monitoring session as desired.

Project Status:

Structure and close in of infill

The infill structure is substantially complete and the infill is closed to weather. However exterior metal panels of the curtain wall were misfabricated, and were also streaked from the anodizing process. These panels are currently being refabricated. The revised delivery date is estimated for May 9, 1997.

Infill interior work

The first floor of the infill is substantially complete and the Museum has received verbal permission from the City of Minneapolis to occupy the area. At the second floor of the infill most dry wall has been hung and taping and sanding of the area is in progress. Some painting has been done. At the third floor of the infill, framing for gyp board walls is nearly complete and some gyp board has been hung. Infill interior work generally lags the issue #3 network model by from 30 to 35 working days.

1st Floor Museum Shop

Acoustic ceilings have been installed at the shop area and installation of hard tile and carpet will be started shortly. Once floor finishes are complete, shop fixtures will be installed, and the shop will be reoccupied. The Museum had requested a later occupancy date of the shop due to the glass exhibit extension.

Docent, kid's area, and coffee shop

The docent area move is being deferred, and construction of the coffee shop and the kid's area is waiting on issuance of a final design. The tentative date of design release is currently June 2, 1997 (wd 618).

Skylight Area

Work at the skylight area has proceeded up to the point where exhibit work can be reinstalled. This work was delayed upon request of the Museum and now is expected to begin about May 12, 1997.

Interior Work at Existing Second Floor

Much of the work at the side library, library, and the archives has been completed, and the Museum is expected to move back in to the side library starting on May 12, 1997 (wd 603). Some wall penetrations into the infill areas have been made at the library areas.

South Asia Gallery (SAG)

The Greco Roman exhibits have been moved by the Museum staff. However demolition of the area had been delayed at the Museum's request until after the Art in Bloom show ended. The show ended May 3, 1997 (wd 598).

Case work design revisions have caused delays to approval, fabrication and delivery of wood trim at the display cases. Witcher received drawings on May 6, 1997 (wd 601).

Bean Gallery

The Bean Gallery has been vacated and demolition at the gallery is substantially complete ready for installation of dry wall and conduit for built in cases.



General:

Overall project work lags by 25 to 35 working days. Mr. McGowan is making a strong effort to plan and schedule Witcher's work on the job so as regain as much of this lag as possible. At our next monitoring and updating session I suggest we update the entire network model, and include all work not covered in our current work plan. This should then allow us to make a reasonably accurate projection of a total completion date as well as setting critical interim dates important to the Museum operations.

I shall be in touch with Mr. Strylund and Mr. McGowan shortly to set ~~the~~ a mutually satisfactory date for our next planning and monitoring session.




General:

There may be some close out items that could extend the completion slightly, but the intent is to complete work just as soon as possible. Some of the areas will not be opened to the public until considerably later than completion of Witcher's contract work. These areas however will also be completed by Witcher as soon as possible to provide a well defined close out target that will fit the Museum's needs and desires as well as those of the design team.

During our monitoring session we reviewed the various action items needed for closing out the project. Copies of this check list were provided to the Witcher staff. I suggest it be reviewed carefully, and if appropriate, it be edited and copies be provided to the Museum staff and the design staff involved.

Required Certificates of Substantial Completion should be obtained for each area from the architect/engineer of record. With these it should be possible to obtain a full Certificate of Occupancy and other permit documents required for the Museum to properly occupy the new and remodeled spaces.








INFILL (1 FL IN)











EXISTING FIRST
FLOOR REMODEL




MUSEUM SHOP REMODELING
