
GUIDELINES FOR YOUR COMMENTS




REGISTRATIONS FOR ASSESSMENT






Of the 39 registrations, 10 reported actual data for the semester (26%). The contingent faculty elected not to participate, in general.




Of the 8 registrations, 9 reported actual data for the semester (129%). The contingent faculty still not to participate.




Of the 17 registrations, 15 reported actual data for the semester (88%). The contingent faculty now began to participate.







RUBRIC SCORE USE BY COURSE




FOREST PLOT OF COURSE RESULTS




PERFORMANCE BY COURSE LEVEL



PERFORMANCE BY GENDER




PERFORMANCE BY RACE






FOREST PLOT OF COURSE RESULTS



PERFORMANCE BY COURSE LEVEL





PERFORMANCE BY GENDER






