#### **President's Post**



Social Life in the Age of Facebook

Every era in a country's history acquires a tagline – the Age of \_\_\_\_. The period of James Monroe's presidency (1817-25) became known as the "Era of Good Feelings" from its lack of intra-party political rivalry. The post-Civil War period of economic expansion and prosperity was called "The Gilded Age" in a book by Mark Twain and Charles Dudley Warner, and the name stuck. The anti-Communist reaction after World War II became known as "The McCarthy Era" after one of its political leaders, Senator Joseph McCarthy of Wisconsin. Typically, the nickname captures an essential quality of the time. We are living in what may be called "The Age of Facebook."

First, a few facts, from various articles accessed via Google:

- At the end of 2004, Facebook users numbered one million. At the end of 2019, there were 2.5 billion – 1/3 of the world's population.
- Americans on Facebook number 221 million 68% of the population.
- The average Facebook user has 338 friends
- 96% of Facebook users access it from

- their mobile phones.
- Until 2010, females were the majority of Facebook users; in 2020, 57% were male.
- The average age of Facebook users in 2019 was 40; in 2013 it was 30.
- 74% of US Facebook users log on in any given day, and the average American spends 41 minutes daily on Facebook.
- In 2020, 300 million photos are posted on Facebook every day.

The voluntary and spontaneous use by so many people of a free Internet-based service means something gigantic is afoot. My daughter reminds me from time to time that "if a website is free, it means you're the product," and we all know that Facebook makes money by mining data about its users, but we continue to make it part of our lives. What unique thing does Facebook add to our lives?

The ultimate answer to this question will take decades to determine, and perhaps by that time Facebook, along with bigbox stores, will be something that Americans used to do, but as a user who is older than average, has more Facebook friends than average, and spends more than the average 40 minutes a day on Facebook, I have a few speculative thoughts, based, of course, on my own experience:

 Facebook offers a way to keep in touch with people from all parts of your life. More than half of my 812
 Facebook friends are part of my 30year life at Ferris and in Big Rapids, but many are family members, hometown/K-12 friends, or friends from school. A surprising number

are people I have never met except through Facebook itself.

- Facebook allows you to share thoughts, life events, and photos with all of your Facebook friends, just a few, or just one. This quality of immediacy, a kind of dailyness, is possible because messages can be sent so quickly and with much less fuss than writing a letter, sending a fax, or composing an e-mail.
- Facebook has created a new kind of friendship. In the B.F (Before Facebook) years, even a person who was very systematic about keeping up friendships lost touch with people in their lives simply because the new that happens in any given day crowds out the old. Facebook allows us to hold on to those people, even if it is only to wish them a happy birthday or laugh at a joke they post. We acknowledge that we may never see them again, but through Facebook they remain a part of our lives.

So, without being unduly conscious about it, we millions of Facebook users have entered a new era in human life, and for the most part, we have done it with enthusiasm. Many Ferris emeriti have Facebook pages. Some are online all the time, some post only infrequently, and some post so rarely that you are surprised to hear from them. Now that I'm retired, I am a committed user. When I wake up, I check my messages; I check them throughout the day; and before I go to bed, I check them again. Yes, I'm a Facebook Addict. I don't want to lose touch with the people in my life, and I don't want them to lose touch with me. So, Facebook, thanks for everything, and I'll try to avoid being unduly crabby or silly in public because I know that anything I put on Facebook never goes away.

#### One Day for Dawgs



#### **FSUEA Scholarship Endowment Update**

#### **FSUEA President's Office Hours**

#### **The SECURE Act Brings Changes to Retirement Plans**

The SECURE Act was enacted January 1, 2020 and includes the most significant changes to retirement plans since 2006. Some of the changes will affect our members including:

- The required minimum distribution (RMD) age changed from 70 ½ to 72 for those who did not turn 70 ½ in 2019.
- Non-spousal IRA beneficiary rules have changed. If anyone other than your spouse is a beneficiary, they must now withdraw the entire amount within 10 years instead of stretching it out over their lifetime.
- If you are still working actively in a second career after Ferris, you can contribute to your IRA longer. The 70  $\frac{1}{2}$  rule goes away for anyone who has wage income.

Rules that have stayed the same include:

- Your spouse's ability to continue to withdraw from the account throughout their lifetime.
- You can still withdraw funds starting at 59 ½ without penalty.
- Those who are 70 ½ or older can still make a tax-free gift of up to \$100,000 from their IRA to a qualified charitable organization without paying income tax on the withdrawal.

Be sure to make an appointment with your financial advisor if you have any questions regarding the impact of the SE-CURE Act on your situation.
