

President's Post



Snowbirds and Winterbirds

Though they are found in 28 states, over 80% of the 650 or so Ferris emeriti have a permanent address in Michigan (leading counties are Mecosta (300+) and Kent (50+). This is not unexpected; wherever they come from, people who spend their careers at an institution in a community develop other ties to that community – family, friends, schools, churches, clubs – that make them feel that this place where they work and live is, or becomes “home.” And if their children are raised there, the community where they grew up and went to school is “home.”

But large number of emeriti also have different winter addresses – in Florida, Arizona, Alabama, or some other state where it’s warm in the winter. In FSUEA, we are reminded of this by the large attendance at emeriti functions in Arizona and Florida. Some emeriti have permanently settled in the Sun Belt, but the seasonally migrating

emeriti – snowbirds – are more numerous. Starting as early as the end of firearm deer season or Thanksgiving, though more commonly after the New Year, off they head to the south – pulling a camper or driving an RV, heading to the trailer park or condo they own or rent.

While in the sunny southland, they swim, play golf, take long walks or bike rides, go fishing, etc. – activities unavailable in the north in the cold months. On warm days they can go outside without a coat, barbeque, or run the air conditioner. And they wear bug spray and swat at flying insects. The pastimes of summer, but in January or February. Those on Facebook or other social media post pictures of themselves out in the sun, reminding us up north that they have escaped winter.

Some come back as early as February, though it’s more common to see them around Easter time. In any case, by the time FSUEA has its spring luncheon in the second week of May at the Rock, a lot of the conversation at the tables is focused on what the snowbirds did down south during the winter.

But not everyone decamps when the leaves begin to fall and the nights turn cold. Many emeriti remain up north year-round, except for vacation travel or family visits. In some cases, health issues keep them close to

home, or the need to economize. But large numbers remain up north year-round because they want to. These winterbirds have spent much or all of their adult lives in a four-season climate; friends and family are here; and their post career activities are centered here.

I'm in this latter group, and to the reasons listed above, I would add that my wife, some years my junior, is still in the workforce, and my stepson is still in high school. We could move permanently if we wanted, but why? Our lives are centered here. At this point, our travel is governed by the number of days Melissa has off.

In truth, this situation is fine with us. I have spent extended time in both Florida and Arizona, and though I love to visit and tour, home is here, in the Great Lakes states. Yes, we have four months of winter, but our springs and falls are gorgeous, and between May and October we have the best weather in the world – warm days and cool nights. It's our secret, and our compensation for shoveling snow in the cold.

Greetings and Thanks from President Eisler

You spent much of your career helping students realize the power of a Ferris education. You know firsthand how lives can change, whether it is inside the classroom or in the laboratory. You have helped build a university community that values students and the pathway for success that a Ferris degree provides. This is a legacy and a commitment that we work hard to continue every day for our students. Although none of us knew our founders, Woodbridge and Helen Ferris, we commit to their ideal that the opportunity of an education is at the core of our values.

You also remember our students and how hard some struggled to stay in school. During my recent Senate testimony in Lansing, I told the story of a returning student who lost state support because of a budgetary decision in Lansing. She believed if she left Ferris and returned home, she would never finish her degree. She also worried that if she commuted the 30 miles between her home and Big Rapids she would not find the time to study and maintain her grades. Determined to live in her residence hall, she made many sacrifices and worked multiple jobs just so she could live on campus. Ultimately, she gave up her meal plan to make this possible.

We created the Ferris Futures Scholarship Challenge to help build scholarship endowments for students, like this determined young woman, who need our support. Through this program, we match dollar for dollar gifts to new and existing scholarship endowments. I want to thank the members of the Emeriti Association for their concerted efforts to build the Emeriti Scholarship Endowment. Many other emeriti have started their own endowments. A contribution of \$12,500 with the match will create a \$25,000 endowment, and you may spread those gifts over five years.

With the Ferris Futures Scholarship Challenge we are creating a new legacy of support for our students, a legacy that will last both Now and Always. In the 18 months since we began this program we have raised \$5 million; with the match this is \$10 million in scholarship endowments. To date, many kind, generous people have created 110 new scholarship endowments for our students.

Thank you so very much for the many things you have done and continue to do for our students. Please know that you are always welcome on campus. We look forward to sharing the many ways our University continues to evolve. When you visit, please stop in and say hello.

President Eisler recently met with current faculty and staff regarding the enrollment crisis that is affecting Ferris State University. The number of high school graduates in Michigan will decline significantly over the next decade, which translates into budgetary cuts which will have a serious negative effect on Ferris and all public institutions of higher learning in the state. President Eisler has requested the Emeriti Board reach out to the collective wisdom of our Emeriti members for suggestions on increasing enrollment and input on how we should approach the necessity to cut between \$17 million and \$20 million from our budget over the next 5 years.
