1. Student must apply for Articulated Credit at Ferris State within two years of high school graduation.

2. Student must complete the Articulated Credit Application/Verification form, gather necessary documentation, obtain appropriate

- signatures, and request that the career technical center/high school send the form and documentation to Ferris State University's Office
 - of Transfer and Secondary School Partnerships.
 - 3. Student must complete secondary career technical education course competencies with a "B" or better final grade.
 - 4. Student must provide a classroom management plan.
