

When Ferris State University authorizes a public school academy, it is an endeavor to positively transform the life trajectory of the students who attend that academy. The Charter Schools Office holds as its most fundamental goal that all students be prepared for success in college, work, and life. We believe that students must be able to apply knowledge to new situations, and to seek out new information through research skills and technological competence. To accomplish this, each academy must provide an environment to achieve academic excellence by delivering quality programming and instruction for the students it serves.

## **Messages From Our Director**

Welcome to a new year with the Ferris State University Charter Schools Office! We're excited to begin with new faces and a refined approach to charter authorizing. Our previous leadership provided a strong foundation, but with rising expectations for charter authorizers, we're committed to continuous improvement. We're updating our practices to align with national best practices, new legal and compliance requirements, and preparing for our 2025-26 Cognia accreditation.



This year, we encountered legislative efforts to increase authorizer oversight and attempts to reduce our funding. Several new Senate bills could significantly impact our oversight responsibilities during the current year. Moving into the future, we expect increased scrutiny in ensuring our academies provide high-quality educational opportunities for the communities they serve.

During this school year, your field representative will introduce our new methods for overseeing and evaluating Academy and Board practices in our four key areas: academic, fiscal, operational, and compliance. We're aligning our practices with the **National Association of Charter School Authorizers's** Principles & Standards, the leading standards for quality charter school authorizing.

As the CSO, we are committed to supporting all our academies, particularly those facing challenges. Our approach involves evaluating performance in the four pillars, identifying issues, providing meaningful support, and maintaining transparency, all while continuously refining our practices to align with best practices and legal standards. We are excited for the future as we embark on developing this new model with you. Thank you!

## **Competitive Grants Are Back!**



Since its inception in 1997, the Ferris State University Charter Schools Office has provided resources to the University's authorized public-school academies in numerous ways. Our Mission Statement sums up that commitment:

"By implementing quality oversight, the Ferris State University Charter Schools Office focuses on student growth and achievement, offers professional learning opportunities, and provides relevant resources to its public-school academies."

Consistent with our Mission, the CSO is pleased to announce that all FSU-authorized academies are eligible to apply for a competitive grant of up to *\$25,000* for the 2024-2025 academic year. The grant may be used for one of four "bucket" areas: **Safety and Security**, **Extra Curricular Activities**, **Staff Professional Development**, or **Other**, which includes projects that do not fit the first three areas. The total amount of funds for the grant program this year is **\$400,000**.

#### **Specific Information:**

- Applicants must complete the *CSO Competitive Grant Request Application* outlining the project, anticipated cost, and rationale for the project.
- Grant requests may be for any amount up to but not exceeding \$25,000 to fund specific projects not covered by the Academy's general fund. The grants are not meant to supplant general budget money, but to enhance offerings or projects that the Academy would not be able to fund otherwise.
- The grant must benefit academy students and/or staff.

## Spotlight on STEM Support – Inland Seas Education Association



The ISEA's fleet includes two ships, the S/V Inland Seas (right) and the S/V Alliance (left).

The Inland Seas Education Association offers a variety of school programs to introduce students to hands-on learning on and around the Great Lakes.

#### **Programs Offered Include:**

- **Schoolship programs:** three hour programs in which students become scientists for the day and assist professional staff and seasoned volunteer instructors with the collection and analysis of Great Lakes samples.
- **ROV Engineer and Explore programs:** programs extend student learning onshore and can be used as stand-alone programs or in conjunction with a Schoolship program.
- Watershed Exploration programs: programs connect students with the Great Lakes by exploring watersheds, exposing youth to Great Lakes careers, and gaining experience with technology and skills used in the field.

For schools coming from greater distances, a 40-bed on-site dormitory space is available.

The ISEA also provides Professional Development opportunities for teachers.

Testing window dates are as follows:

- FALL: August 19, 2024, to October 11, 2024 (8 weeks)
- WINTER: December 2, 2024, to February 7, 2025 (10 weeks)
- SPRING April 21, 2025, to June 13, 2025 (8 weeks)

**UPDATE**: Due to the NWEA summer session window beginning June 15<sup>th</sup>, the CSO has moved the date for the spring session up by one week.

There is a student participation goal of 95% or higher for grades 2-8 It is optional for students enrolled in grades K-1 and 9-12 but is **strongly encouraged**.

A formal invitation from Angela Irwin will be emailed to board members. The invitation will include a brief description of each session and registration instructions.

Each board member that attends or watches a webinar or interactive session can earn one professional development credit for their respective board. To earn the credit, the board member must share 2-3 takeaways from the session at a board meeting.

Boards are required to have at least two board members complete at least three credits per academic year. FSU Field Representatives will periodically report on your board's standing with professional development credits.

## In-Person Board Professional Development Opportunities

In addition to our virtual board training series, we are thrilled to offer board members an inperson board professional development opportunity this fall. Again, we are partnering with seven other Michigan charter school authorizers. Angie Irwin will provide a formal presentation followed by a breakout session/table discussion facilitated by Angie and the authorizers and ending with the attendees re-convening for a meal together.

The session will walk through governance framework based on best practices, which will include the following "governance buckets":

- Policy & Practice
- Planning & Relationships
- Operations & Procedures

The interactive sessions will encourage board members to consider their practices and processes and determine into which "governance bucket" these practices and processes should be placed. Participants will leave with an outline of a governance framework that they can build upon and refer to as they execute their respective governance roles.

There are five regional sessions to choose from. The same content will be repeated at all five locations. The session will begin at 5pm and end by 8pm. The dates and locations are as follows:
