## **Title IX Recommendation**

In a recent email from NCSI, it was recommended that academies continue to implement policies that comply with the 2020 Title IX regulations, including the Institute's Policy and Administrative Guideline 2266.

We recommend that academy boards hold off on rescinding or suspending the new Policy/Administrative Guideline 2264 that many adopted in recent months, as well as removing any text from Policy/Guideline 2266, which limited its application to complaints alleging conduct occurring prior to August 1, 2024, as other ongoing court cases and pending transition to the new administration in the White House may impact this decision or the 2024 regulations.

Training and response to complaints and allegations of discrimination and/or harassment on the basis of sex should focus on the 2020 Title IX regulations.

## **Admissions Event for Seniors**

Graduates of Ferris-authorized

academies may be eligible for automatic admission to Ferris State University and a \$3500 scholarship. This is made possible thanks to Ferris' Momentum Endowed Scholarship and Enrollment Program.

The CSO has been working directly with school leaders and guidance counselors at academies with grades 9-12 to spread the word about this opportunity.

#### **Eligibility Requirements:**

- The scholarship is only available to students attending FSU full-time as an undergraduate student, taking classes online and/or in-person
- Students must be graduates of a public school academy authorized by FSU
- Students must have a minimum 2.35 GPA at the time of application
