Proposal Number	Title	Notes
19-047	COB Core Refinement	<p>Affects 96 checksheets across the university. There are pre-req changes. The biggest issue is the swap of micro and macro economics. If you do nothing to you checksheets when this change comes to pass, you may add an extra course to your course load.</p> <p>FSU is one of the only colleges teaching the econ courses in the sequence it was taught. Need to add BHR to the list of programs affected.</p> <p>The Detailed Impact sheet in the handout shows the course changes. If you are happy with how the changes affect you we have to work together to modify your checksheets.</p> <p>IF you have both Econ classes, it may not be a big deal. If you only have one course, you have to decide what you want to do. If you are good with changing from micro to macro, then it's a simple change to econ 201. If not, you will need to decide what course you want to change to. If you do nothing, the proposal moves forward and you will have a closed course on your checksheet.</p> <p>Example: If MGMT 370 is on your checksheet, some decisions have to be made because the pre-req for this now is ECON 201 and MGMT 301. If they aren't on their checksheet, you have to decide if you still want this or change to a similar course. Same with MKTG 321.</p> <p>The Timeline is aggressive. Has to be signed and sent to UCC by Feb. 28th. It would go to Senate by 3/5 meeting. Registration is right after spring break. Action needs to be taken on your part immediately. Students can see the schedule in 2 weeks. They will see ECON 221 & ECON 222. ECON 201 & 202 can't exist until it's an approved proposal. Amy suggested that they plan ECON 201 & 202 are scheduled as the same time as ECON 221 & 222. Your semester layout will also being changed. COB has to list what they are doing to the semester layout. COB is applying that they keep Gen. Ed. Status.</p>

	<p>If you are fine with flipping them and there are no changes, you can sign your checksheet and turn them in and we are good. Amy is concerned that if the layouts are done, then we may not make the 2/28/19 deadline.</p> <p>There is a concern about the students who are in the pipeline? If they took one and not the other, are you going to make 221 a pre-req to 202?</p> <p>Macro is first and the first 1/3 of the course is micro so it takes away from the course. They end up wasting a lot of time. Most places do the micro first. It would eliminate having repeat and review.</p> <p>We are going to send out the Form B's to every dept affected by this change and Form A hopefully this week so that the group can get their decisions back. Greg Wellman said that we should include the business group so that the responses are expedited. Mark Branley, COB, offered to answer any questions if people have them.</p> <p>If you are fine with the flip, sign and date the checksheet and turn it in and Amy's group will make the change. If there are other things, you will need to work on them. IF you have changes to your pre-req, send them to Teresa Cook, she will take them to the committee and if approved, get them to fsucurriculum.</p>
