1. Go to **www.gcntraining.com**
2. Click on "Login to View Training"
3. On the Pre-Login Checklist, click on "Login to View Training" again
4. Select Existing User – I have a Personal ID
5. Click "next"
6. Organization ID: **ferrisstateuniversity**
7. Click "submit"
8. Personal ID: "**BANNER ID**"
9. Click "submit"
10. Access tutorials from the list of tutorials on the left of the screen
11. Click "view," next to the tutorial of your choice
12. Verify your information and the tutorial summary
13. Click "Start Tutorial"
14. Follow the audio / visual prompts to complete your tutorial

Tutorial availability is broken in to two categories. Some tutorials are required while others are optional. These requirements are based on the employee job classification.

The certificate of completion includes all tutorials completed and can be printed by the employee at any time. However, to save paper, try to limit printing until multiple tutorials are completed.
