

#### Ferris State University Fiscal 2021-22 General Fund Operating Budget Preliminary Recommendation June 2021

The University general fund operating budget is submitted for approval by the Board of Trustees in two stages. A preliminary budget is recommended in the spring to establish tuition rates and base operating support levels for the new fiscal year which begins on July 1. In the fall, when enrollment and State funding decisions are known, a final budget is presented.

#### Fall 2021 Enrollment

The major driver to the general fund budget is student enrollment. Enrollment Services office projections for next fall reflect an estimated 1% reduction in the number of students at Big Rapids/regional sites, and Kendall is projected to decline 9%. Total estimated annual student credit hour enrollment is 266,013.



#### Projected Summer 2021 Enrollments

Summer enrollment is projected at 8% below last year's level. This reduction is included as part of the preliminary budget recommendation.

### State Funding

At this time there is uncertainty regarding state funding for Michigan universities. The executive budget recommendation for higher education included a 0% base increase and a 2% one-time increase. Legislative budgets have been moved out of the appropriations subcommittees but have not been considered by the appropriations committee. There is wide disparity in these preliminary legislative recommendations. The Senate recommendation is a 0% base increase for higher education, but does include a one-time increase of 2% plus an additional \$57K for Indian Tuition Waiver. The House proposal includes an allocation of funding based on each university's rolling 3-year average number of FYES, which would result in a 10% increase for FSU. The House

proposal is a significant change from previous funding approaches; it would decrease funding for some institutions as much as 10% and increase for others as much as 12%.



The following chart reflects legislative recommendations to date:

To qualify for federal stimulus funds which have already been distributed to public schools, the State must meet a Maintenance of Effort (MOE) for higher education, which would result in another \$2.5M for FSU for the FY21 budget. To this point the legislature has not approved this action. There is the possibility of a waiver on the MOE, which the state received last year, but that seems unlikely. While the Department of Education has not yet released its instructions for American Rescue Plan Funds, it seems likely that the MOE will continue at least through the 2023 budget. MOE will be a safeguard against state funding reductions to higher education over this period.

This preliminary budget assumes a 2% funding increase, based on the Executive recommendation.

The projected \$57 million State appropriation supports 28.3% of the recommended preliminary revenue budget.

It is expected that this year's appropriation cycle may take longer to complete. Any additional budget adjustments required because of State funding decisions will be reflected in the final budget recommendation in the fall.

#### Tuition and Fees

The proposed 2021-22 tuition rates stay within the current predicted State tuition restraint limit of 4.2%, while addressing fixed cost increases of \$2.9 million (\$3.8 million for compensation and \$1.0 million for scholarships, which are offset by a \$1.9M reduction in Operating Support).

The University is recommending an average 3.16% undergraduate tuition increase (2.71% lower division; 3.62% upper division). The greater increase for upper division student rates reflects the higher costs of upper division instruction. Graduate tuition rates are recommended to increase at 4.1%. The impact to undergraduate Net Cost of Attendance is 1.8%.

There is one special adjustment reflected in the proposed FY22 tuition rates. Kendall studio instruction is costlier to provide due to specialized equipment, space requirements, and small class sizes. This tuition has increased at a higher rate over the past several years. As a result, a smaller increase, 2.0%, is recommended for FY22.

There are two requested tuition waivers. First, where there are 25 or more international students attending the university through a contractual agreement, these students would be billed at the normal undergraduate tuition rate. International contracts qualifying for this tuition rate will be reviewed annually. Second, where a Memorandum of Understanding has been signed with a Michigan community college, students who are attending the community college through the Future for Frontliners or the Michigan Reconnect programs, upon admission to the University would be permitted to take up to 12 credits of Ferris classes at the in-district community college rate.

#### Tuition and Fee Revenue

The recommended tuition rates applied to the estimated enrollment level will yield tuition and fee revenue of \$141.9 million, up \$1.4 million from the FY21 revenue level.

Other revenues for FY22 increase from FY21 within this recommendation due to reinstatement of the On-Line Student Fee and a projected increase in Parking Fees and Fines.



#### **Compensation Expense**

The recommended preliminary budget supports inflationary and contractually mandated compensation increases. Salary expense is projected to increase \$2.0M, and increases in fringe benefit costs will require an additional \$1.4 million. Overall compensation is projected to increase \$3.4M (2.5%) for next year.

#### **Student Assistance**

The preliminary budget supports \$26.5 million of scholarships funded through a combination of base and one-time support. An increase in total student assistance funding is included with base support in the FY22 budget. Student assistance continues to include \$1.2M in interest income from the Ferris Futures endowment.
