In the term section enter the term; use the 4-digit year and two-digit month (example: Fall 2014 should be typed as 201408; Spring 2014 as 201401 or Summer 2014 as 201405).

	<b>NOTE to the Registrar's Office:</b> The exception to this rule is Study Abroad (ORSA. They should have the Voice Response and Self-Serve Available unchecked. LLS classes uncheck <b>Print, Gradable, and Voice Response</b> and check <b>Tuition and Fee Waiver</b> .

### Search for Existing Course Reference Numbers (CRN) or find the next section number

Find an existing CRN or determine next available section number:

- Enter the correct term information.
- Use the elipsis after the CRN to execute a query.
- Use the Add Another field drop down to select what field(s) you want to query by such as Subject and Course. You can add as many query fields as necessary to narrow your search.
  - You will probably want your first query field to be the term, that is not automatically assumed even though you had a particular term in the Term Section of SSASECT.
- Use the empty field to enter the text you want to query on, such as ENGL
- Execute the query by selecting Go or F8.
- Double click on the CRN to bring it into SSASECT.

### Add Feature

Adding a section:

- Enter the correct term information.
- Type ADD in the CRN field.
- Go to the next section (ALT + PAGE DOWN) and fill in the fields.
- The new CRN will automatically be assigned to the section when the save function is performed on the first section.

### Copy Feature

Use the copy function to add more sections with the same or slightly modified information. Leave the section number as zero (0) on the existing section you are going to copy.

- Make note of the CRN you want to copy, which will be the zero section number.
- Stay in the **Term Section**, type ADD in the **CRN** field and select or TAB to prompt the **Copy CRN** button.
- Enter the CRN of the section you want to copy and press Process Default. The zero (0) section has now been copied into a new CRN
- Repeat as needed.
- Once all new sections are added, change the zero (0) section to the next available unused section number; usually the first number in the sequence.
- The copy feature copies the first section information only. This will include the Enrollment Data. It does not copy the meeting or instructor sections.

**Title**

Titles are not to be changed for course sections. Exceptions to this rule are as follows:

- \_90 sections which are always assigned a title per the Form F paperwork.
- \_97 sections if the credit hours are changed from variable to fixed credits.
- EDUC\_94 if the credit hours are changed from variable to fixed credits.
- RMLS 101 sport sections.
- Sections of courses designated for Honors (only adding to existing to title Honors or HRNS)

**Section**

Numbers are used for on campus sections and letters are used for EIO sections. Section codes are to be sequential; 001, 002, 003 or 211, 212, 213; 221, 222, 223 or, for example, NTA, NTB, NTC for sections held in Traverse City. Fully online sections are coded as VL1, VL2, VL3, etc.

Study Abroad sections will have the Section code of 401, 402, 403, etc. The Campus code is OS for these sections. Study Abroad sections are to have the default attribute of **MFSU** entered on **SSAETL**. The **BIG** code is removed.


Code **BBD** is assigned by an automated process in Student Financial Services for various courses. Please do not add or remove this attribute.

EIO section abbreviations can be viewed by using the drop down box in the **Campus** field. Use the code that will reflect where the course will be offered, such as:

- EF for Flint
- NT for Traverse City
- AG for Grand Rapids

EIO sections will need to have an attribute added or removed on **SSAETL**. Accounts Receivable will use these codes to indicate special billing requirements. Depending on the location of the section, one of the following codes should be entered on **SSAETL** in the **Degree Program Attributes** section and the **MFSU** and **BIG** codes are removed:


**EAST** East Michigan    **MID** Mid Michigan    **NRTH** North Michigan  
**WEST** West Michigan    **ATC** Grand Rapids

	<i>If your <b>Campus</b> starts with an "E" the SSAETL attribute would be EAST, "N" – NRTH etc.</i>

**Fully On-Line (Internet)** course sections will have **Section** codes built using VL (Virtual Learning) as the first two characters followed by a number; VL1 (1<sup>st</sup> section), VL2 (2<sup>nd</sup> section), etc. If you build more than 9 sections, the sectioning changes to V and the two digit number, V10 etc.


The code entered on the first section of **SSASECT** in the **Campus** field should always be flagged with an "MB" for Big Rapids/EIO. Fully On-Line sections never have "M" in the campus field.

The attribute **WBD** (Fully On-Line) must be added to the **Degree Program Attributes** on **SSAETL**. In addition to the **WBD**, all EIO Internet sections are to have the default attribute of **MFSU** or can be changed to **1VL** entered on **SSAETL**. The **BIG** code is removed.

	<i>By assigning 1VL vs. MFSU, no refundable fees will be charged (best used for classes offered to EIO or fully online students only). It will also read "Priority Reg to Off Campus" vs. "Big Rapids Tuition."</i>

**Campus**

Big Rapids (main campus) uses **M**, and Kendall uses **K**. Clicking on the down arrow will produce all available EIO campus codes.

Fully On-Line section campus codes entered on the first section of **SSASECT** should be flagged with an "MB" for Main Campus.

Study Abroad sections should be coded as OS.

	<b>NOTE:</b> <i>Changes to campus codes after registration has begun for the term should not be made. If the change must be made all students must be dropped from the section, the changes made, and then all students are to be re-added.</i>

**Status**

Status indicates whether the section is **(A)** active, **(C)** cancelled, or **(T)** temp closed. Sections flagged with **T** or **C** prevents enrollment and are not viewable on the Internet (Look up Classes).

Course sections can be temp closed with day, time, room, and faculty left on the system. To cancel a course, any registered students should be dropped, the course should be temp closed, and all information must be removed from instructor section of **SSASECT** before submitting the request to RRC. To keep a section viewable on the Internet, but restrict registration, the enrollment number can be entered as zero.

Course sections that are closed because the seating/enrollment capacity has been reached will be visible on Look up Classes but there will be a “C” that replaces the registration check box a student would normally click on to register for the section.

### **Schedule Type**

**DO NOT** enter the codes of **WBD** (Fully Online Delivery) or **WBM** (Mixed Delivery/F2f Online Supplement) in the **Schedule Type** field on the first section of SSASECT. The code of CLL for lecture/lab combination sections is to be entered on the first section and separated into the lecture and lab portions on the second section. To change incorrect codes in the Schedule Type field requires removal of all information on the second and third sections of SSASECT.

These are commonly used schedule type codes: LEC, LAB, CLL (combined lecture laboratory), IND, SEM, etc.

### **Special Approval**

Department permits (**DP**) or Instructor permits (**IP**) are entered in this field. This code will block all students from registering themselves into the section. Permit designations are easily viewed by students on Look up Classes as long as an attribute code of 1PRM (Permission Required) has been assigned to the **SSADETL** form in the Degree Program Attributes field.

### **Part of Term**

- Use the elipsis in the **Part of Term** field to select a **Part of Term**, or enter the code.
- Press ENTER or tab to fill in the date fields.
- Choose the **Part of Term** that fits the date range of the course.

Part of Term information can be viewed in the Registration and Academic Guide located various places on Ferris’ home page.

### **Credit – Billing Hours**

If you have a variable credit course that you are changing to a fixed credit, the information is to be entered in the field below the variable **Credit Hours** and **Billing Hours** fields.

In some manner, you will want to take note of the credit and contact hours for combination lecture/lab courses before leaving the first section. Many times this information will need to be manually entered/fixed on the second section in the **Hours per Week** and **Session Credit Hours** fields.

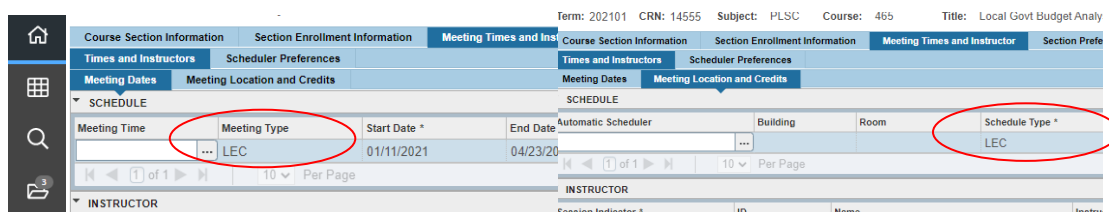
**Detailed information for entry:**

**Meeting Time**

- Click on the down arrow box to view and select approved days and times.
- Double-click on a code or use the function keys SHIFT + F3 to bring the information forward to this form.
- Dates and times can also be entered manually.

**Meeting Type**

Update the Meeting Type from CLAS to the schedule type for that part of the course. For example, if the schedule type for part line in banner is LEC then the Meeting Type should be LEC. Or WBD and WBD, LAB and LAB, PRA and PRA etc.



**Start and End Dates**

Start and end dates should fall within the approved term calendar. The Vice President of Academic Affairs Office, through the dean’s office, must approve any exceptions.

All sections are to have Start and End Dates, including those that are TBA. If you need the days/times TBA, you must have the Start and End dates, Schedule Type, Hours per Week and Session Credit hours filled in.

Specific dates can be built using the Start and End Date fields. Examples would be a class meeting 3 weekends or a course meeting for only one week of the term.

**Days**

Enter days by clicking in the box below the day of the week the section will meet. Helpful Hint: As you tab through the days, pressing on the space bar will enter or remove a check mark in the day fields.

If either days or times are unknown both fields are to be left blank until complete information is available.

Banner sorts sections with multiple lines in the order of days of the week rather than schedule type. Therefore, a lecture/lab course could have the lab portion of the section listed before the lecture portion.

**Start and End Times**

Times are entered using military standards. Building a cheat sheet may be helpful for some people. Something along the line of 1:00PM is equal to 1300, 2:00PM is equal to 1400, etc.

All section times should end with a 15, 20, 30, 45 or 50 minute time. Class sections do not end on the hour. Some ending time examples are 9:15, 13:50, 17:20, 17:45. For consistency purposes this applies to EIO sections also.

If either days or times are unknown both fields are to be left blank until complete information is available. Changes/exceptions to the matrix require dean approval.

**Auto Scheduler, Scheduler Preference, Partition Detail, Room Attribute Details**

We will not be using the above fields at this time.


**Building/Room**

This part of the system compares room size to section size. Sections can be built in rooms too small for the set max enrollment of a section; however, a pop up box will inform you of the room size discrepancy.

If either the building or the room is unknown both fields are to be left blank until complete information is available.

To search for a building or room:

When in the **Room** field on SSASECT, click on Options and select **SLQMEET**, Query Available Class Room. This will give you available rooms by building. The Records Office has added departments, and room attributes as selections to be used on **SLQMEET** for added search features in the **Desire Room Attribute** section.

	<i><b>NOTE:</b> Using SLQMEET may change the Schedule Type and the Hours per Week. This information will need to be re-entered.</i>

Selecting the down arrow box under **Room** brings you to SLQROOM. You can enter a building code and then **Execute a Query** (F8). This will bring up a selection of classrooms for that building.. However, this query does not indicate building or room conflicts. It is suggested the **SLQMEET** be used to find rooms.

**Web Focus reports are available for an alternative way to view classroom space.**

**SS0009-RB (SSAMATX); SS010-RB (SLIAEVN); SS011-RB (SLARDEF)**

**Banner forms that can also be used:**

**SLIAEVN** or **SSAMATX** forms can be used to search for available rooms and **SLAEVNT** is used to build or view special events. **SLARDEF** is the room definition form.

The **SLIAEVN** form is used to check room availability.

- Access the form and enter the pertinent information. Leave **Room Type** as **All**.
- **Next Section** (ALT + PAGE DOWN) to enter room attributes.
- **Next Section** (ALT + PAGE DOWN) to display available rooms. This part of the form does not have a scroll bar so you may need to arrow or page down to view all available rooms.

The **SSAMATX** form is used to search for classes or events already booked in a building or room. This form displays the term, dates, days, times, building and room for classes or special events. And it has a few quirks.

- Entering day information will greatly restrict the search for information. An example, if I check all the days, Monday through Sunday, the only return information I will receive will be for classes/events held all seven days.

- If you want to see classes and special events in a room do not enter a term in the term field. By entering the term the form will not display special events.
- Start and End Dates must be entered as day/month/year. Example: 30-MAY-2014.

SLAEVNT is the special events form. When searching on SSAMATX and a special event is booked in a room a person can copy and paste the CRN (event number) into SLAEVNT to view information about the special booking.

The form SLARDEF will list information about a room such as ownership, attributes, inactivity and special comments.

## Schedule Type

For lecture/lab courses, be sure to change **CLL** (combined lecture lab) to **LEC** for lecture and **LAB** for the lab portion of the section.

This is also where Internet codes are replaced from **LEC** or **LAB** to **WBD** (Fully on-Line). If a course is **WBD** (Fully on Line) the approved Hours per Week and Session Credit Hours fields are filled in with the approved contact and credit hours from the first section of the form. If the course is a combined lecture/lab course the WBD code is used for both schedule types (lecture and lab). For courses that are fully online but are meeting online at designated dates and times, enter those days and times on the meeting times block of SSASECT with the schedule type of **SYNC** in addition to the **WBD** line with no days and times. For these synchronis courses, also add the attribute of **SYNC** to SSADETL.

Virtual Reality courses are built like face-to-face courses so long as they are meeting full contact hour in the VR classroom (otherwise they may need mixed delivery added). VR courses also have attributes of **VR** and **VRH** added to SSADETL.


If a course is **WBM** (Web Based Mixed Delivery/ F2f Online Supplement) an additional line must be entered to designate the mixed delivery portion of the section. The Hours per Week and Session Credit Hours are filled in on the LEC, LAB, etc. line of the section and zeroes are entered on the WBM line in these fields. WBM is used when the course is mixed delivery and Hours per Week are NOT met.



If contact hours are met, but the Internet will be heavily used, the attribute type of **WOCR** should be entered on **SSADETL**.

If a course is **SLA** (Structured Learning Assistance) an additional line must be entered to designate that portion of the section. The Hours per Week and Session Credit Hours are filled in on the LEC, LAB, etc. line of the section and zeroes are entered on the SLA line in these fields.

The entry of some Schedule Types will cause a message to display “WARNING, Section does not have this schedule type code.” We still don’t know why this message appears but the message is a warning only and allows the change to be made. If you do have a schedule type that can’t be entered contact the Registrar’s Office to update the catalog.

	<b>NOTE:</b> Be sure to attach the correct attribute on <b>SSADETL</b> for <b>WBD, WBM, WOCR</b> and <b>SLA</b> sections so students can easily view this information on <b>SSB</b> .

### Override Indicator

This must be checked to override any schedule conflicts, such as scheduling two or more sections in the same room at the same time.

**DO NOT** enter an Override Indicator on **SSASECT** unless you intentionally want to override a building and/or room. Overrides should not be done on the first section of a course.

- **T** overrides time conflicts
- **R** overrides room conflicts
- **O** overrides both

It is suggested to use the **O** option.

### Hours per Week (Contact Hours)


Refer to the first section of **SSASECT** for the correct break down of these hours.

Any section not meeting 50 or 75 minutes per meeting time will need to have the **Hours per Week** manually adjusted/corrected. (Ex: If you have a LAB which meets for a 3 hour block, i.e. 0800-1050, this will auto-calculate as 3.40 hours per week. You would need to manually adjust to correctly show 3.00 hours per week).

There must be hours entered in **Hours per Week** or faculty cannot be added to the section. PRA and IND sections do **not** have contact hours. In these cases the entry of zeroes is necessary. TBA sections should have all fields left blank except the **Date, Hours per Week, Session Credit Hours** and **Session Indicator** fields.

If adjustments are made to Start and End Dates, Days, Times and sometimes to the Building /Room fields, these changes should be saved and then the **Hours per Week** manually corrected.

Combination lecture/lab courses may need to be manually changed to reflect the correct break down of the **Hours per Week** for the section. Summer term will be manual entry for all Hours per Week information.


	<i><b>NOTE: If there are multiple lines for one Schedule Type, enter contact hours only in the first line of each Schedule Type. Zeroes are entered in the following lines.</b></i>

For sections meeting multiple hours (evening or weekends) all break and lunch times are to be incorporated when figuring **Hours per Week**. When classes are scheduled in blocks of more than two hours, accommodations for a 10-minute break for each two-hour time block must be included.

**Session Credit Hours (Credit Hours)**

Refer to the first section of **SSASECT** to determine the correct hours.

Combination lecture/lab courses will need to be manually changed to reflect the correct break down of credit hours for the section.

	<i><b>NOTE: If the course is combination lecture/lab, the lecture contact and credit hours should be the same. The lab contact hours are actual meeting hours and the lab credit hours are what are left after credit hours are used for the lecture.</b></i>

If there are multiple lines for one Schedule Type enter credit hours in only the first line.

Variable hours will always be reflected as the minimum number or the fixed number entered on the first section.

**Session Indicator**

This code defaults to 01. If the section is a combination lecture/lab, 01 should be used for the lecture portion of the section and 02 for the laboratory.

The SLA line of the section will be coded as 03.

**ALL** other sections will have a session indicator of 01 regardless of the number of lines used to enter the section. This includes lecture, lab only, independent study, internet (Fully on Line), mixed delivery, etc.

Press F10 to save this information. Go to the next section (ALT + PAGE DOWN).

### Session Indicator

The session indicator in the Instructor section ties to the session indicator in the meeting dates section. For every session indicator in the meeting dates section a session indicator needs to be assigned in the instructor section. For example, even if the same instructor is teaching both the lec/lab of a course, the instructor will need to be listed twice, as 01 and 02.

The SLA portion of a section does not have an instructor assigned.

### ID

Clicking in the name field to the right of the ID field, faculty can be searched using the same search methods for students. Upper/lower case is not needed when using this method to search for a faculty name.

When searching using the ID field you must either know the faculty ID or click on the down arrow button to go to the query form **SI AIQRY**. In this form go to the next section (ALT + PAGE DOWN).

- Tab to enter the faculty last name or portion of the last name, enter the wild card (%), and Execute a Query (F8) to display a list of faculty name options. **This field is case sensitive. You must type the name in upper/lower case.**
- Double-click on the ID to assign a faculty member to the section. Press Save (F10).
- To remove/change faculty names, start with the last faculty name on the form and perform a record remove (SHIFT + F6). Repeat as needed and Save (F10) when completed.

All faculty assigned to a section are able to enter grades for that section. Some coordination may be required to insure grades are correctly assigned to all students.

If the **Instructor** section is left blank in SSASECT, self-serve will indicate TBA in the instructor field.

Overloads for faculty are entered on the form SIAASGN in the Assignment Type field. The down arrow box will list available options. See the faculty overload section of this manual for further instructions.

### **Instructional Workload**

This field is not used at this time.

### **Percent of Responsibility**

This is used to designate the instructional workload and session credits. The Percent of Responsibility total should not exceed 100%.

### **Primary Instructor**

This designates the primary instructor. There can be only one primary instructor for each section. All instructors assigned to a section can enter grades.

When changing instructor names the current name must be removed (record remove) and the action saved before entering a new name. If there are multiple instructors assigned to a section the removal process must take place from the bottom up with the removal of the **Primary Instructor** taking place last.

### **Override Indicator**

The override checkbox is used to determine if the faculty schedule will be checked for conflicts. The valid entry is **O** – Override instructor conflicts. Do not enter an override code unless the faculty member is going to teach multiple sections in the same day, time, building and room.

If a faculty override is not desirable, available faculty can be searched for by selecting **Options** from the menu, and then selecting Query Available Faculty (**SIAFAVL**).

### **Percent of Session**

This field must be filled in with 100.

**FSPO – Fall Split Overld. Paid in Spr (\*\*see additional Split Overload instructions below)**

**ROVL – Ranked Overload**

**SOVL – Staff Overload**

**SPOV – Split Overload (\*\*see additional Split Overload instructions below)**

**UOVL – Unranked Overload**

When entering overload information and you receive the message “\*ERROR\* Instructor Schedule Conflict” you need to click in the **Override Conflicts** field on the far right side of the form. This message will display when entering overload information for lecture/lab sections that have multiple listings of the lab portion of the section. Once this field is checked the **Assignment Type** can be saved.

If the class has more session indicators of 01 and 02 (CLL), please ensure this is done for both sessions of the course. 01 and 02 have their own row and each need this field populated.

If you need to delete an **Assignment Type** delete and save F10.

Go to the next section (ALT + PAGE DOWN) to the second section of SIAASGN to enter release time assignments on the Faculty Non-Instructional Assignments section.

**\*\*Split Overload or Annualized split overload** are also entered on the first section of SIAASGN by using the SPOV for Split Overload and code FSPO Fall Split Overload Paid in Spring. These codes are entered into the Assignment Type field. After choosing the SPOV or FSPO code accordingly hit OK and then save F10.

While the same course is highlighted click More Information on the tool bar. This will open a new box in which the overload and regular % can be entered. ONLY numeric values are to be entered. Do not enter the actual % sign. After entering the numbers save, F10.

### FCMO, ADMO and EXMO

ADMO, FCMO or EXMO are entered on the first section of SIAASGN in the Assignment Type field using the following codes:

**ADMO – Admin Zero Dollars, Zero FTE**

**FCMO – Faculty Zero Dollars, Zero FTE**

**EXMO – External professional/Expert in the field, Zero FTE**

**Scenario 1 – FSU instructor for \$0- Courses for which a FSU faculty is assigned but there are no instructional dollars or FTE associated with the course.**

Instructor of record will be added at 100% responsibility with FCMO code. No administrator. The courses themselves will have a code assigned to them in SCADETL, through the Curriculum Process, in order to monitor that a FCMO is assigned.

**Scenario 2 – Non FSU Instructor for \$0- Courses for which a non FSU faculty is assigned and there are no instructional dollars or FTE associated with the course.**

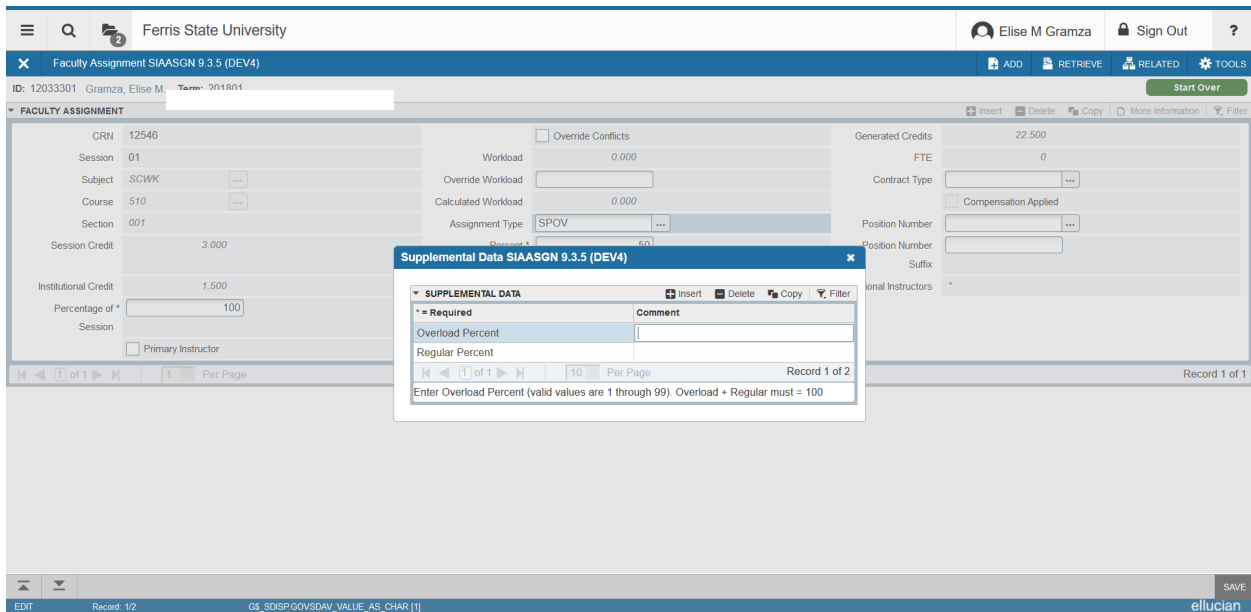
Non FSU instructor of record will be added at 100% responsibility with FCMO code. No administrator. After review, might suggest adding MSC1 to this scenario (previously under scenario 4). Non FSU instructor could be added as an affiliate, if not already, through HR and coded them using this new function.

**Scenario 3 – Non FSU professional for \$0 (Courses for which an external professional/expert in the field is facilitating and administering the course outcomes, assessment and ultimately determining the grade.**

Instructor of record will be added at 100% responsibility with EXMO code. The courses themselves will have a code assigned to them in SCADETL, through the Curriculum Process, in order to monitor that a FCMO is assigned.

**Scenario 4 – FSU Administrator is the instructor of record for \$0 – Courses for which a FSU administrator is assigned but there are no instructional dollars or FTE associated with the course.**

Administrator of record will be added at 100% responsibility with ADMO code.



Once Supplemental Data has been tied to a course there will be data under More Information.

## Release Time

The **Type**, **College**, **Department** and **TOPS** fields must have pertinent information entered. At this time the rest of the fields will not be used.

Release time codes can be viewed by clicking on the drop down box in the **Type** field. Enter the appropriate code. If you are unable to find a code/description that closely matches your needs for a specific release time please contact the Institutional Research Office, extension 3800, for assistance.

**College**, **Department** and **TOPS** codes can be viewed by clicking on the drop down box in the **College**, **Department** or **TOPS** field. Enter the appropriate codes.

### Section Long Text

This is a message area that will appear on self-serve when a student clicks on the CRN to get detailed information about the section.

The course descriptions for **\_90** and **\_97** courses are entered in this field.

## Additional Information

---

### SpecialTopic(\_90)andSpecialStudy(\_97)Courses

The **Title** is not to be changed for courses other than \_90 or \_97. This type of course can be given a section title by typing it in the **Title** field. If a title is assigned, the hours need to be changed from variable to fixed on the first section of **SSASECT**

Please note that both \_90 and \_97 courses should be assigned in accordance with the level of the subject matter. If a request is made for a 390 or 397 then the subject matter should be equivalent to a 300 level course.

The **\_90 courses** are Special Topic courses that can be held two semesters using the same Form EF. The Registrar's Office must have a Form F on file before processing requests for \_90 courses. The title, plus credit and contact hour information is entered from this form. These courses can be held in a variety of ways. They can be entered into the system as lecture, lab or combination lecture/lab courses with fixed credit hours. The course description is to be entered on **SSATEXT** so students can view this information.

\_90 sections must be assigned a title. This information is entered in the **Title** field. Credit hours are entered in the fields just below the variable **Credit Hours** and **Billing Hours** on the first section of **SSASECT**.

\_90 courses need to be approved by the department, the Dean's Office and the VPAA Office. After the second time they are held, the course either has to follow the approval process to be entered as a new course or not be held again using that title and description.

\_97 courses are designated Special Study (Independent Study) courses. These courses are normally built for 5 or less students. They are held as TBA without assigned days, time or room. The course work is done independently by the student with supervision by a faculty member.

**For faculty load purposes the department head/chair or other administrator is entered as the instructor with 100% responsibility. For grading and record keeping purposes the instructor working with the student should also be listed on the course with 0% responsibility.**

The course normally remains on the system with the generic title and variable credit, but if the course is to be changed from variable to fixed credits a title must be added to the **Title** field of the course or included with the request. Fixed credit hours are entered in the fields just below the variable **Credit Hours** and **Billing Hours** on the first section of **SSASECT**.

The course description is to be entered on **SSATEXT** if the credits are fixed and a title is assigned.

### GraduateTopicsin Education (\_94) Courses

This type of section should be given a section title by typing it in the **Title** field. Credit hours are entered in the fields just below the variable **Credit Hours** and **Billing Hours** on the first section of **SSASECT**. These courses can be held in a variety of ways with fixed credit hours. The course description is to be entered on **SSATEXT** so students can view this information.

## Approved Enrollment Number

Go directly to SCADETL and go to the Supplemental Data tab. The enrollment number is in the Credit Category field.

## Scheduling and Catalog Screens

In addition to the **SSASECT** form, the following forms may be used when building sections of courses. The information on the forms **SSADETL**, **SSAPREQ**, **SSARRES** will normally be brought over from the information entered in the Course Catalog. Changes to these forms can be made based on what is appropriate for each section.

- **SSADETL**  
Use this form to enter attributes on the **Degree Program Attributes** section. Common attributes, but not all, are the Permission Required code (1PRM), regional location codes (North, East, West, Mid, ATC), Internet and Mixed Delivery codes (WBD, WBM), SLA, etc. Once registration has begun, changes to this form may affect student billing.
- **SSARRES**  
This form is used to enter college, field of study, class, or level restrictions on a section. When entering a code the **Include/Exclude** field must be marked correctly. Please do not use the program restrictions option.
- **SSAPREQ**  
This form should not be used.
- **SCACRSE**  
This is the Basic Course Information form (view only) that lists title, college, department, status (active or inactive), credit and contact hours, if the course is repeatable, level, grade mode, and schedule type.
- **SCADETL**  
This is the Course Detail Information form (view only) and it contains information such as co-requisites, equivalent courses, degree attributes (similar to the list given for SSADETL), the official enrollment number for a course, and the course description. Within the description the terms offered and any pre/co requisites are also listed.
- **SCAPREQ**  
The Catalog Prerequisites and Test Score Restriction form (view only) lists all required prerequisite(s), associated grade(s), and test score information for the course.
- **SCARRES**  
The Course Registration Restriction form (view only) shows college, major, class, or level restrictions.

If contact minutes are over the required contact minutes, subtract required contact minutes from requested contact minutes \_\_\_\_\_ divided by number of meeting times = minutes that need to be subtracted from each meeting time \_\_\_\_\_.

### Below is an equation example for computing the correct contact hours:

Activity contact hours 3 x 750 min per contact hour = required meeting contact minutes 2250

Total required minutes for schedule type 2250 divided by total meeting times 12 = required min for each meeting time 188 plus 10min for break = 198 = 3 hr and 20 min.

## Matrix Information

---

### Fall and Spring Term Class Information – Semester Transition Manual Fall 1993

Most institutions on the semester system use a Monday-Wednesday-Friday, Tuesday-Thursday calendar, at least through the early afternoon hours. The typical MWF classes are 50 minutes long and the typical TR classes are 75 minutes long.

Classroom scheduling will be improved with the MWF, TR concept. In a given three hour block of time, a room could be scheduled for three MWF classes and two TR classes.

To achieve the maximum utilization of classroom space and to facilitate student scheduling, departments/units are encouraged to follow the class scheduling recommendations listed below.

All lecture courses require 750 minutes of instructional time per contact hour. A 2-contact hour class = 1500 minutes, a 3-contact hour class = 2250 minutes, a 4-contact hour class = 3000 minutes and a 5-contact hour class = 3750 minutes.

Class Scheduling Suggestions (Please remember the scheduling of classes must follow the approved matrix)

- If the class is scheduled for two lecture hours per week, those hours should be scheduled in one of the following configurations:
  - MW or MF or WF for 50 minutes
  - TR for 50 minutes
  - Any day for 100 minutes if the class meets at 3:00 p.m. or later
- If the class is scheduled for three lecture hours per week, a department/unit is encouraged to use one of the following configurations:
  - MWF for 50 minutes
  - TR for 75 minutes
  - MW for 75 minutes, if the class meets at 3:00 p.m. or later
- If the class is scheduled for four lecture hours per week, those hours should be scheduled in one of the following configurations:
  - Any four days for 50 minutes
  - MW for 100 minutes, if the class meets at 3:00 p.m. or later
  - TR for 100 minutes, if the class meets at 3:00 p.m. or later
- If the class is scheduled for five lecture hours per week, those hours should be scheduled in one of the following configurations:
  - MTWRF for 50 minutes
  - MW for 50 minutes, and TR for 75 minutes
- Laboratory hours may be scheduled any day of the week. However, if a class requires multiple weekly sessions, they should be scheduled in either TR or MWF time blocks.

### Campus Meeting Times

Classes should not be held from 11:00 to 11:50 on Tuesday and Thursday. These time slots are reserved for meetings. Those courses which require three hour laboratories could schedule laboratories from 8:00 to 10:50, from 12:00 to 2:50 and from 3:00 to 5:50.

Course offering configurations starting at 3:00 p.m. do not have to follow the Monday-Wednesday-Friday 50-minute or the Tuesday-Thursday 75-minute timeframe.

Classes will not run later than 10:30 p.m. without dean and VPAA approval.

Changes/exceptions to the matrix require dean approval.

When classes are scheduled in blocks of more than two hours, accommodations for a 10-minute break for each two-hour time block must be included.

All classes must be **scheduled within the Board approved academic calendar** for each semester. Classes scheduled outside this timeframe will require department, dean and VPAA approval.

Once early registration has begun, courses scheduled both on and off campus must include days and times the classes will meet. The dean of the appropriate college must approve any exceptions.

Any combination of days may be used. Example: Three day courses may be held M,W,F or M,T,W or W,R,F. The only requirement is they must meet contact hours and fit within the above time frames.

Classes are not to run later than 10:30 p.m.

Classes do not need to follow this matrix after 5:00 p.m. in the summer term. They do need to meet contact hours.

Changes/exceptions to the matrix require dean approval.

It is imperative that the course schedule matrix be followed so students have the opportunity to develop a schedule of courses in both their major and general education with minimum conflicts. As the enrollment increases, it is necessary to follow the matrix to provide maximum usage of our available classrooms.

### **Guide for Summer Term Matrix Configurations by Part of Term**

Accommodation for a 10 minute break has been incorporated into these times for courses meeting two hours or more per guidelines from the VPAA Office.

#### **Part of Term D, E, F (4 weeks)**

Each one contact hour class meets 750 minutes. This could be accomplished by meeting:

1 day for 200 minutes;      2 days for 95 minutes;      3 days for 65 minutes

Each two contact hour class meets 1500 minutes. This could be accomplished by meeting:

1 day for 375 minutes;      2 days for 200 minutes;      3 days for 125 minutes;      4 days for 95 minutes;  
5 days for 75 minutes

Each three contact hour class meets 2250 minutes. This could be accomplished by meeting:

2 days for 305 minutes;      3 days for 200 minutes;      4 days for 155 minutes;      5 days for 115 minutes

Each four contact hour class meets 3000 minutes. This could be accomplished by meeting:

2 days for 400 minutes;      3 days for 250 minutes;      4 days for 200 minutes;      5 days for 160 minutes

Each five contact hour class meets 3750 minutes. This could be accomplished by meeting:

5 days for 200 minutes

#### **Part of Term A, B (6 weeks)**

Each one contact hour class meets 750 minutes. This could be accomplished by meeting:

1 day for 125 minutes;      2 days for 65 minutes

Each two contact hour class meets 1500 minutes. This could be accomplished by meeting:

1 day for 260 minutes;      2 days for 125 minutes;      3 days for 85 minutes;

4 days for 65 minutes;      5 days for 50 minutes

Each three contact hour class meets 2250 minutes. This could be accomplished by meeting:

1 day for 415 minutes;      2 days for 200 minutes;      3 days for 125 minutes;

4 days for 95 minutes;      5 days for 75 minutes

Each four contact hour class meets 3000 minutes. This could be accomplished by meeting:

4 days for 125 minutes;      5 days for 100 minutes

Each five contact hour class meets 3750 minutes. This could be accomplished by meeting:

4 days for 170 minutes;      5 days for 125 minutes

**Part of Term G, H (8 weeks)**

Each one contact hour class meets 750 minutes. This could be accomplished by meeting:

1 day for 95 minutes          2 days for 50 minutes

Each two contact hour class meets 1500 minutes. This could be accomplished by meeting:

1 day for 200 minutes;      2 days for 95 minutes;      3 days for 65 minutes;      4 days for 50 minutes

Each three contact hour class meets 2250 minutes. This could be accomplished by meeting:

1 day for 305 minutes;      2 days for 155 minutes;      3 days for 95 minutes;      4 days for 75 minutes

Each four contact hour class meets 3000 minutes. This could be accomplished by meeting:

2 days for 200 minutes;      3 days for 125 minutes;      4 days for 95 minutes;      5 days for 75 minutes

Each five contact hour class meets 3750 minutes. This could be accomplished by meeting:

4 days for 120 minutes;      5 days for 95 minutes

**Full Term (12 weeks)**

Each one contact hour class meets 750 minutes. This could be accomplished by meeting:

1 day for 65 minutes

Each two contact hour class meets 1500 minutes. This could be accomplished by meeting:

1 day for 125 minutes;      2 days for 65 minutes;      3 day for 45 minutes

Each three contact hour class meets 2250 minutes. This could be accomplished by meeting:

1 day for 200 minutes;      2 days for 95 minutes;      3 days for 65 minutes;      4 days for 50 minutes

Each four contact hour class meets 3000 minutes. This could be accomplished by meeting:

1 day for 270 minutes;      2 days for 125 minutes;      3 days for 85 minutes;      4 days for 65 minutes;  
5 days for 50 minutes

Each five contact hour class meets 3750 minutes. This could be accomplished by meeting:

3 days for 105 minutes;      4 days for 80 minutes;      5 days for 65 minutes

Keep in mind that due to the shorter Parts of Term during Summer term, if you offer a section meeting one day of the week, and a holiday falls on that day of the week, you will need to add extra time to that section. This may also be the case for four week Parts of Term sections meetings two days a week.

Courses meeting **one day with a holiday falling on that day** for the full term use this guide:

Each two contact class meets 1500 minutes. This could be accomplished by meeting:

11 times for 140 minutes

Each three contact class meets 2250 minutes. This could be accomplished by meeting:

11 times for 215 minutes

**Added Notes:**

Some days and times listed above do not fit within the approved matrix configuration. Courses meeting more than 180 minutes won't meet the approved matrix. It is suggested they not be held before 2:00 p.m. They are included only as a reference and in the instance of a non-matrix course receiving dean approval.
