### President's Post



Ramping Up for the Fall

One of the first reminders of the meaning of retirement for newly retired faculty occurs in early August. It's not something that does happen, so much as something that doesn't happen – you don't have to get ready for the fall semester!! But, since the actual New Year's Day in America is not the first of January but the first Monday in September – Labor Day – even we who are retired and live in an empty nest can't help but notice all the hubbub going on around us.

Newspapers and catalogs feature back – to – school clothes for kid and fall styles for adults. Cabela's and other outdoor outfitters highlight rifles and bows and other hunting equipment. As early as the middle of August, college students quit their summer jobs and head for Ann Arbor, Bloomington or other destinations. Even in mid – August, K12 schools start to open. School athletic practice fields are suddenly filled with the sounds of football drills, or with marching bands learning complex halftime show routines. By now, families have taken those long vacations or attended distant family reunions and returned. It's time to focus on preparing for the new year – the school year.

We retired professors were part of this mighty torrent of activity for many years - first as children growing up, then with our own families if we had children, and for a long time, at work. After a June and July spent thinking about anything but the classroom (even though we had promised that THIS YEAR we would thoroughly revise all our teaching materials and be ready AT THE VERY LATEST by the beginning of August), we would look at the calendar, count the days, and begin thinking about how ready we would be in, say, three weeks. Before the age of online learning and course management soft-

ware, when instruction was mostly face – to – face, we spent many hours running off and collating our syllabi and handouts, sometimes in multi – colored paper. We would look at last year's syllabi, those documents of purpose and hope, and recall what worked and what didn't. We'd look at our class lists, if they were available. And we would hope that last – minute cancellations or resignations did not result in a new and unexpected workload. If we had not hitherto taught in a particular classroom, we'd go have a look at it, especially if it was in another building across campus. We'd go up to the office and spend a day opening our accumulated mail and greeting colleagues we hadn't seen all summer. The faculty office halls in our buildings began to hum with activity.

All this was necessary for a very simple reason: effective classroom teaching requires that you establish a rapport with a group of (mostly) young people whom you have never met and who are the age of your children or grandchildren. Establishing that rapport means they'll listen to you when you talk about evolution, the Reformation, or semi – colons for a whole semester. That fifteen – week semester can be very long if you get off on the wrong foot, so you psych yourself up to a cheerleader pitch for that first day, when you exude enthusiasm for your subject and interest in the students. This effort is a lot of work, but you don't mind, because you are putting your shoulder to the wheel as a part of a great and unending enterprise – the education of the young.

Now preparing for an online course is different in many ways – the most important being that you may never see your students, and they may never see one another, and you may only rarely see your colleagues. But that's a topic for another column.

We retired academics remember our years in the classroom with fondness and pride – but at the same time, we're happy to be doing something else at this time of year. Enjoy the fall and the memories this time of year brings back from your own career!

Greeting new students and their parents as they prepare to make the transition to college and seeing our campus come to life as the fall semester begins has a dynamic to it that never grows old.

If you have walked our campus recently you have seen many of the changes, with much work on sidewalks, pavement and grounds. Our Student Recreation Center renovation brings a fresh new face and expanded exercise facilities. We will have the grand opening for this on Monday, August 27, at 6 p.m. as a part of Rec Fest. The Swan Annex will be open for the beginning of school and will provide much-needed space for Advanced Manufacturing, Mechanical Engineering Technology and Welding Engineering Technology. ## Emeriti Scholarship Endowment Status

With your donations and the *Ferris Futures* match, our fund now totals *\$71,561!* We are very near to building the endowment to a level that can support **three** scholarships per year (\$75,000 required). Let's make that next milestone! It will only take an additional \$1,750 in bundled contributions, matched by the *Ferris Futures* program, to top \$75,000!

We gave out our first award last year to a student in the College of Arts & Sciences and this year we will give out our second award to a student (yet to be named) in the College of Business since we are rotating through the five undergraduate colleges alphabetically. Our stretch goal is to increase our fund balance to \$125,000 during the remaining years of the *Ferris Futures* match program so we can *annually* give out an award to a student in *all five* undergraduate colleges.
