

Greetings from President Pink

To my friends in the Emeriti Association,

Scholarship Endowment Update

As most of you know, we conducted our annual "bucket" campaign in September instead of December this year because the Ferris Futures matching fund was rapidly being depleted. Thanks to your generosity, we received \$1,300 in donations, but we only received \$1,200 in matching funds. We literally drained the last drops out of the matching fund. The market value of our endowment is now in excess of \$222,000 and we are able to annually give an award of about \$1,500 to a student in each of the 5 undergraduate colleges at Ferris. This ability was the stretch goal when we implemented the endowment, and thanks to your generosity and the matching funds, we succeeded in reaching our goal. GOOD ON US!

The Ferris Futures matching fund was created by President Eisler and the Board of Trustees when the State of Michigan refunded money to several higher education institutions that had overpaid into the state retirement pool. FSU's refund was approximately \$17.9 million. At the initiation of the matching fund rules, the University decided the least donation amount that would be eligible for the match was \$1,000. Hence, our Association created a "bucket" to place donations in so individual emeriti could donate less than \$1,000 but our "bucket" total would exceed \$1,000 and get the match. This strategy has worked very well since 2016 when the match was initiated. However, in the future, we will not be conducting anymore "bucket" campaigns unless a new matching fund is created by the University, and the \$1,000 minimum rule is reinstituted. You may still donate to this fund at any time during the year by sending a check (to the address below) made out to The Ferris Foundation with Emeriti Scholarship Endowment written in the memo line.
