Students are admitted to the School of Education at Ferris State University as an entering freshman. During their first two years they are guided through the general education courses and Level 1 teacher education courses. These courses are designed to give students a good introduction to the field of teaching along with the expectations of the profession. Students must pass these courses with a grade of "C" or better and may not have more than two repeats for the three Level 1 courses. At the completion of the Level 1 courses the students are required to complete a Level II application. This application asks the students to meet with their advisor to develop a plan of study, complete a criminal history form, sign a professional behavior form, review their GPA- which must be at a 2.5 minimum, have completed 35 hours of general education coursework, taken the required testing to meet the Basic Skills Examination, have a clearance from the Department of Human Services showing no problems related to child abuse or neglect, and have demonstrated work with children. Upon successful completion of this application the student is then allowed to register for professional education courses at Level II.

Student teachers are given increasing responsibility for directing the activities of the classroom group to the point of and assuming responsibility of a lead teacher. Student teaching is assigned at the appropriate levels in elementary or secondary public schools or post-secondary settings, and is supported by regular participation in the online community where innovative instruction and assessment methods, as well as major topics of interest, subject area, classroom management, and pedagogy are discussed.
