MESSAGE FROM THE PRESIDENT

For the past several months the Ferris community has watched as the heart of our Big Rapids campus has undergone a major transformation. The opening of our renovated University Center in the beginning of January will be accompanied by changes in roadways and sidewalks designed to make campus more accessible to our students, faculty members, staff members and visitors.

FOUNDATION'S EXCEPTIONAL MERIT GRANT RECIPIENTS ADVANCE UNIVERSITY GOALS OF ENGAGEMENT, LEARNING

Ferris State University Automotive majors will gain working knowledge of electric vehicles and battery technology that will give them an edge in the future job market.

Optometry students will learn techniques involved in pediatric eye examinations and get hands-on training to help patients in need of vision rehabilitation.

Ferris students in a variety of disciplines will benefit from innovative research opportunities, thanks to \$44,500 awarded by The Ferris Foundation to faculty and staff members to pursue initiatives that have significant educational and outreach potential.

"The Ferris Foundation Merit Grants provide crucial and often foundational support for trailblazing initiatives that are creating positive and lasting change for Ferris State University students and community members in Michigan and around the nation," said Carla Miller, the foundation's executive director. "Every year, the foundation's Gifts and Grants Committee looks forward to seeing more new and fresh ideas to fund."

Recipients for the 2014-15 academic year received funds for initiatives designed to advance student learning and faculty engagement. They are:



Patrick English, associate professor College of Engineering Technology Vehicle Battery Technology

Students will get hands-on experience with battery cells, packs and testing equipment, and also get to explore what types of batteries make up the hybrid electric, extended-range electric and full electric vehicle battery packs. Graduates with a good working knowledge of electric vehicles and battery technology will have the edge in the future job market.

"The first generation of a new wave of electric vehicles has started. The battery is the stumbling block to vehicle range improvements. This will concentrate the focus of future efforts for improvements on the battery itself," English said in his proposal. "This project is the beginning of a larger project intended to bring advanced battery testing to Ferris."



Sarah Hinkley, associate professor and chief of Vision Rehabilitation Services Michigan College of Optometry

Students in Need of Eyecare, Interprofessional Collaboration in Vision I

Interprofessional Collaboration in Vision Rehabilitation for Student Education and Patient Care

Hinkley received grants for two proposals. The first project expands the Michigan College of Optometry's "Students in Need of Eyecare" program into the community, teaching optometry students the techniques involved in pediatric exams as well as providing opportunities for clinical research and community service.

"Schools provide routine vision screenings through the public health department, yet teachers and school staff have identified that a need still exists for identifying at-risk children and ensuring that they actually receive eye examinations and glasses," Hinkley noted in her proposal.

Since 2001, The Ferris Foundation has awarded more than \$400,000 in Exceptional Merit Grants to support a variety of innovative and collaborative projects.

Since the program was initiated last year, MCO has been approached by many area schools wishing to participate in the program, she said.

The second grant will help fund her proposal to expose students and patients to the value of an interprofessional approach to vision rehabilitation through a partnership with the Association for the Blind and Visually Impaired in Grand Rapids.

"This hands-on career training is essential to student success as a practicing optometrist, particularly if they have an interest in vision rehabilitation as part of their practices," Hinkley wrote in her proposal. "The partnership is unique, making MCO one of the only optometry schools in the country to use a teambased approach within its own clinical services. Our students will leave their clinical training in vision rehabilitation ready to care for patients with vision loss in the most innovative and effective way."



Jennifer Johnson, professor College of Arts and Sciences

Assessing the Urban Heat Island of Big Rapids

Johnson, a 2014 Distinguished Teacher of the Year recipient, was awarded an Exceptional Merit Grant to study the urban heat island effect in Big Rapids. The grant was used to purchase sensor equipment that will be installed in and around the community.

"The urban heat island, characterized by elevated temperature in developed areas, is a pressing issue for many industries,"

noted Johnson. The grant project will yield information useful across disciplines.

"Students in architecture, construction management, energy systems and HVAC, for example, must all take into account building design and energy efficiency when planning projects. Buildings located in urban areas will experience greater heat load in the summer," her proposal stated.

Cameron Shoemaker, one of Johnson's students, received a Student Research Fellowship to study last summer with Johnson. The field experience will help him compete for a research assistantship that could pay for his graduate education in geography.



Lisa Salvati, associate professor College of Pharmacy

Medication Therapy Management Sub-Contracting Service

Salvati is using her Merit Grant award to pilot a Medication Therapy Management sub-contracting service through Ferris' Pharmacy Care Clinic, which will create opportunities for students to interact directly with patients and health care providers and to gain management experience. It will be piloted as a business, potentially generating revenue for the college and creating a model program for other community pharmacies.

"MTM services allow the pharmacist to become intimately involved in the patient's plan of care ... to help the patient achieve very measurable outcomes to improve overall health

and well-being," Salvati said in her grant proposal. "Pharmacy students, under the guidance of pharmacy faculty and preceptors, will conduct patient interviews, gathering medication histories and medication adherence rates, as well as reviewing for any barriers that prevent the patient from achieving optimal outcomes."



Susan Wancour, assistant professor Denise Byrnes, clinical instructor College of Health Professions Intraoral Digital Dental Camera

Wancour and Byrnes are using their award to bring stateof-the-art digital intraoral camera equipment to Ferris State's Dental Hygiene students.

The IOC allows practitioners a real-time view of oral conditions and makes storage and transmission of data faster for consultations, predeterminations and referrals. Digital photography also reduces patients' exposure to germs and is more comfortable for patients than an endoscope. These benefits have created a demand for graduates with IOC training in the job market.

"The dental hygiene profession is committed to delivering the highest quality of care to each of its patients and applying advancements in technology and science to continually improve the oral health status of the population," wrote Wancour in her proposal. "This project demonstrates exceptional merit in advancing the mission of Ferris State University and the dental hygiene profession by providing innovative learning opportunities through advanced IOC technology."



Mary Beth Zimmer, associate professor College of Arts and Sciences

Research experience for students

Zimmer received a partial award to help support a research experience for several students and present results on the effect of spinal cord injury on learning and memory. Jacqueline Tieu, one of Zimmer's students, received a Student Research Fellowship to study with her last summer.

Research experience such as this opens doors for students after graduation, Zimmer noted.

"Some of our students gain the knowledge from classes that allow them to enter professional schools, such as medical school, optometry school, dental school, etc. However, many of these top professional schools also require or strongly recommend that the students have some research experience," Zimmer wrote in her grant proposal. "Research experiences allow our students to really understand what the scientific process is about. They allow the student to work on a specific question, run experiments without knowing what the outcome will be, gather data, critically analyze and interpret the data, and draw conclusions based on their experiments in relationship to other studies in the field."

Grant recipients are chosen by The Ferris Foundation's Gifts and Grants Committee, which is made up of foundation directors, faculty and staff members. Up to \$7,500 per project is available to support pilot programs, purchase equipment dedicated to program objectives, match grant expenses, fund research with students and other endeavors.

\$1.5 MILLION 'BE A PLAYMAKER' CAMPAIGN WILL HELP POWER BULLDOG HOCKEY PROGRAM

"Be a Playmaker," one of Ferris State University's largest athletics-related fundraising campaigns, will ensure the continued success of Bulldog Hockey in NCAA Division I. The \$1.5 million endowment campaign already has raised more than \$882,000 in private support to help sustain the program's elite status.

The campaign is off to a strong start, thanks in part to a lead gift from Bulldog Hockey legend Chris Kunitz ('03), now an NHL All-Star with the Pittsburgh Penguins. The two-time Stanley Cup champion and Olympic Gold Medalist and his wife, Maureen, also a Ferris State graduate, remain strong supporters of the university and Bulldog Hockey.

"Be a Playmaker" will raise funds to provide resources for recruiting, team travel, strength training and conditioning,

and performance technology along with facility upgrades that will allow the Bulldog Hockey program to compete at the highest level.

"I'm proud to be an alum of the Bulldog Hockey program and excited to be part of this steering committee helping to secure the future for Ferris State," Kunitz said. "Our gift will help both current and future student-athletes and the Bulldog Hockey program continue to leave a big impression in the college hockey world, and I encourage others to help support this great cause."

Kunitz is joined by a number of familiar faces on the "Be a Playmaker" steering committee, including chair

Chris Bowers ('78), Gary Cousino ('73), Lyle Nagle ('76) and Zach Redmond ('11), a member of the NHL's Colorado Avalanche. Former head coach Rick Duffett, who was the school's first Division I coach, is serving as co-vice chair along with Kunitz. Former Ferris State University President and hockey program founder Robert Ewigleben is part of the steering committee, which also includes past player-parent Dick Redmond and Board of Trustees vice chair Sueann Walz.

"Our goals and aspirations are aggressive, but we can't do it alone, and the support of Bulldog Nation will provide necessary resources to support our effort to remain among the top teams in the country on a daily basis," said head coach Bob Daniels, a two-time NCAA Division I National Coach of the Year who has embarked on his 23rd season at the Bulldog helm this year. "The ongoing support of our donors will help ensure a first-class experience for our student-athletes while they earn their degrees and compete at the highest level of collegiate athletics."

The Bulldog men's hockey program has been a treasured part of the university and West Michigan for more than 40 years, bringing national attention to Ferris State on numerous occasions.

The program produced 24 NHL draft picks during its formative years from 1982 to 1999. Bulldog Hockey alumni in the NHL include such past standouts as Rob Collins, John Gruden,


Dave Karpa, Greg Rallo, Chad Billins and Andy Roach, along with Kunitz.

Since those early years, the Bulldogs have continued their remarkable journey and ranked among the nation's best over the past decade, producing their top seasonal performances at the NCAA Division I level, a trio of league regular-season championships, three NCAA Division I regional championship trips, an NCAA Frozen Four Championship berth, three Hobey Baker Award finalists and multiple American Hockey Coaches Association awards since 2003.

The program's success hasn't stopped on the ice.

The Bulldogs also have ranked among the nation's 10 best teams in the classroom, and the program annually contributes to a wide range of worthwhile charitable and community service projects as a way of giving back to its faithful fans, who often fill Ewigleben Ice Arena to produce one of the top home-ice advantages in the country.

Throughout the program's rich history, student-athletes have continually taken their game to the next level, and last season the hockey program joined the Western Collegiate Hockey Association, an opportunity that calls upon Bulldog student-athletes, along with fans and supporters, to continue to be at the top of their game.

NURTURING THROUGH NATURE

Ethan Axtmann grew up in a playland of tall grasses and towering trees, where otters played in the creek and deer created a maze of paths to explore each morning. Today, it is a haven of educational opportunities for Ferris State University students.

Axtmann and his sister, Aleta Hursh, chose to honor their late parents by gifting the family's 92-acre pristine property near Horsehead Lake in Martiny Township to Ferris. Now known as the Harold and Pauline Axtmann Family Nature Preserve, the land will be utilized for academic work by students majoring in such fields as surveying or the biological sciences.

"It's a beautiful property — a sanctuary for birds and other wildlife, and there are many vegetation types," Axtmann said. "I'm very happy that Ferris is taking over its preservation and that it will benefit students."

OTTO KAMPTNER'S PASSION FOR SAFETY MEMORIALIZED WITH SCHOLARSHIP FOR CRIMINAL JUSTICE STUDENTS

Ferris State University alumnus, United States Navy veteran and community advocate Otto Kamptner, who passed away Jan. 2, 2014 at the age of 84, was passionate about safety and education. His wife of 36 years, Elaine, has created a scholarship endowment in his name that embodies the values he lived.

Otto was an avid volunteer in the Big Rapids community. He helped start the Big Rapids Little League program and coached young baseball players for 20 years. He also served on the Big Rapids Public Schools Board of Education from 1968 to 1976, joined the Mecosta County Sheriff's Posse from 1968 to 1994 and was a member of the Big Rapids Jaycees and VFW Post No. 4102.



His spirit of volunteerism and dedication to education will have a lasting impact on Ferris students through the Otto Kamptner Memorial Scholarship Endowment, which provides financial assistance to Criminal Justice majors.

"When he was in college, he worked seven part-time jobs, cared for his family, transported a disabled friend to classes and carried a full class load," Elaine said. "He very much appreciated the GI Bill. There was no scholarship assistance then, so it was a struggle. When he was younger, he wanted to

be an attorney but couldn't afford the additional cost of law school. He always had a passion for the law."

That's why she chose to honor him through a scholarship endowment that will help Ferris students seeking a career in law enforcement better afford a college education.

"He would be pleased that we are adding Ferris women and men to 'the good guys' — he was one of the good guys," said Elaine, who often assisted Otto at the various safety classes he taught, including boater, hunter, marine, ORV and snowmobile. "He was passionate about safety and teaching young people. He loved to teach others."

His volunteer safety instruction through the Mecosta County Sheriff's Department continued until December 2013.

Elaine also is a Ferris alumnus along with their son, Joshua, and several other family members; a great-grandson is a current Ferris student. The couple have given to Ferris over the years and are members of the Old Main and Abigail Smith Timme donor societies.

"We believe strongly in education," Elaine said of why giving to their alma mater was important to the Kamptners. "Ferris State University has done so very much for me."

Elaine, who joined Ferris in 1985, serves the university as executive assistant to President David Eisler. She also chairs the university's Pride Committee.

Creating the scholarship endowment to benefit students is a way for her to honor her husband, Elaine said, noting such a memorial is available to people who may not think it is a viable option.

"You don't have to have a lot of money to honor the memory of someone you love," said Elaine, who expressed appreciation for the many donations made to the scholarship endowment by individuals and businesses.

The Otto Kamptner Memorial Scholarship will be awarded annually to a full-time undergraduate student.

"It is so fitting that Elaine decided to continue to support both the profession Otto so proudly served and the university that she serves so endearingly by providing means for a student to continue their studies at Ferris," said Steven Reifert, interim dean of the College of Education and Human Services. "This scholarship helps by allowing students to continue to study at Ferris and to work toward their dreams of serving the criminal justice profession, as Otto did."



ELDER ESTABLISHES SCHOLARSHIP TO ATTRACT, ASSIST DESERVING FUTURE PHARMACISTS

Jean Elder has been a high-profile advocate of children and families, the elderly and disabled, and under-served populations. During her 40-year career, she's worked to improve people's lives through public policies and philanthropy. Her most recent philanthropic effort will help Ferris State University students seeking a career in pharmacy.

Elder created an endowment fund to provide scholarships to students working toward a Doctor of Pharmacy degree. The Jean K. Elder Pharmacy Scholarship Endowment will be awarded annually to a full-time student based on financial need.

Elder, whose professional experience includes service in the U.S. Department of Health and Human Services, Michigan's Department of Education and Department of Community Health, was awarded an honorary doctorate from Ferris in 2009. She was tapped to join The Ferris Foundation Board of Directors in 2010.

"Having served three-plus years on the foundation board, it's become very apparent that most Ferris students need scholarship help," said Elder, who chairs the foundation's Strategic Planning Task Force. "Clearly, we want Ferris State University to continue to attract and retain students of high academic skill and personal merit. I established the scholarship to do just that: attract and assist deserving students in the College of Pharmacy."

Elder has deep Michigan roots, from earning three degrees from the University of Michigan — culminating in a Ph.D. in education and psychology — and serving on faculty at various Michigan universities prior to her appointment by President Ronald Reagan as commissioner and assistant secretary for the U.S. Department of Health and Human Services.

She returned to Michigan from Washington, D.C. in 1990, and served five years as deputy director of the state's depart-

ment of community health. Since 1995, she has held senior management positions for the Council and Accreditation for Children and Family Services in New York, and Maximus Inc. in Reston, Va.

In 2006, she established J.K. Elder & Associates in Ann Arbor, Mich. While that work keeps her busy, Elder is passionate about her position with The Ferris Foundation.

"We know that private support has become a critically important part of the equation leading to excellence at any university," said Elder, whose daughter-in-law, Jodie, is an associate professor in the College of Pharmacy. "The scholarship endowment is a wonderful legacy as it advances the mission of The Ferris Foundation."

More than half of all pharmacists practicing in Michigan are Ferris graduates. They are employed in every type of pharmacy practice and at every level of the pharmaceutical sciences.

"The investment in a pharmacy student also brings with it the added benefit for society, providing a medication expert for a society that is becoming increasingly dependent on medications and their beneficial effects in controlling or reversing disease," said Stephen Durst, dean of the College of Pharmacy. "The fact that Dr. Elder is not an alumna of the college makes her commitment even more meaningful."

The endowed scholarship will reduce the burden of educational loans and allow for heightened focus on studies and the development of practice skills, Durst said.

"Most importantly, it demonstrates to the recipient that they are not alone in their 'pharmacy journey'," he said. "There are individuals eager to support them in their pursuit of a career in pharmacy."

MIKOLS ENDOWMENT FUND POWERS WELDING ENGINEERING TECHNOLOGY PROGRAM

Joseph and Linda Mikols want to support opportunities for generations of students who choose Ferris State University.

That's why the former Ferris professor and his wife created the Joseph S. Mikols Scholarship and Welding Program Laboratory Equipment Endowment Fund through their estate to provide scholarships to students majoring in Welding Engineering Technology as well as to purchase needed equipment.

"We are both proud of the FSU mission, and we want to do our small part in preserving the quality of the experience our students receive and to demonstrate that we have faith in the future of the FSU Welding Engineering Technology program," Joseph Mikols said of the nationally recognized program housed in the College of Engineering Technology's School of Design and Manufacturing.

"After spending 35 years as a welding engineer and then as a welding engineering educator, I wanted to do something to demonstrate my commitment to helping students develop skills that will position them for optimal industry employment," continued Mikols, an emeritus member of The Ferris Foundation Board of Directors. "Serving on the Welding Engineering Technology faculty gave me an appreciation for the excellent education and training our students receive; the quality of the faculty is world-class. Evidence of that can be seen in the top-level jobs our students secure upon graduation and the growth and advancement they subsequently achieve in the industry."

His service on The Ferris Foundation board made Mikols more aware of "how an endowment can help bridge funding gaps during cyclical variances in income as well as provide startup money to launch new initiatives or expand existing ones.

"We felt the endowment was simply the best way to ensure the long-term continuation of a very successful program," Mikols said. The scholarship will be awarded to a sophomore, junior or senior undergraduate student majoring in Welding Engineering Technology. The program is the largest of its kind in the United States.


"One of our main motivations to fund scholarships through this endowment is so that students can reduce the level of debt they accumulate upon graduation," said Mikols, an associate professor of Welding Engineering Technology from 1986 until his retirement in 2000. "When I served on the foundation board's Gifts and Grants Committee, I not only saw how much need there is for some of our students, but I was inspired to hear the sacrifices and heartaches students often incur to achieve their educational goals. Anything we can do to alleviate the financial stress on students assures that students gain the full benefit of their education."

The Mikols are members of the university's Carillon and Abigail Smith Timme Societies of Distinction.

Their endowment will help attract future students as well as assist current students in need, said Larry Schult, dean of the College of Engineering Technology.

"The scholarship will also serve as motivation for students to excel within the program," he said. "It attracts top high school and transfer students to it already, and this scholarship will help maintain and increase that high standard."

Additionally, endowment funds earmarked for laboratory equipment will enhance the hands-on learning that is a cornerstone to the university's Engineering Technology programs, Schult said, and equipment purchases will ensure students have cutting-edge technology at their disposal.

FISCAL YEAR 2014

The fiscal year ending June 30, 2014 concluded another very strong year financially for The Ferris Foundation. At the end of June 30, the foundation market value grew to \$47.7 million, its highest level in the history of the foundation. The endowment portion of these assets grew to \$46.3 million. This record high was achieved through the combination of additional new gifts to the endowment of \$804,368 during 2013-14, as well as an overall portfolio return of 17.1 percent against the portfolio target weighted index of 13.7 percent.

As of June 30, 2014, The Ferris Foundation endowment comprised of 346 individual endowed funds, which also is a new record for the foundation.

In addition, the foundation's investment returns, as reported in the 2013 NACUBO-Commonfund Study of Endowments, shows strong relative performance for The Ferris Foundation against national comparative data. For the fiscal year ending June 30, 2013, the foundation's portfolio performed at a level that exceeded the average performance for other endowments in the \$25- to \$50-million tier and for all four measurement periods including one-year, three-year, five-year and 10-year returns. Further, the 10-year return of 8.4 percent for The Ferris Foundation, compared to other like-sized endowments, outperformed the national data by 200 basis points.

The national comparative performance is referenced here for the period ending June 30, 2013 due to the timing of NACU-BO-Commonfund releasing the study results each year. The final results from the national study are typically not available until February following the fiscal year end.

The investment pool of the foundation is overseen by an active Investment Committee with the assistance of an independent investment adviser, Fund Evaluation Group, and supported by the University Administration and Finance staff and the foundation executive director. The foundation board continues to support changes to the endowment asset allocation on a regular basis to allow the portfolio to move into alternative and private asset classes.


Over the last 10 years ending June 30, 2014, the 4 percent spending policy of the foundation has resulted in providing approximately \$9.6 million in support to student scholarships and other important areas of focus for the foundation.




THE FERRIS FOUNDATION ENDOWMENT VALUES

Market Values as of June 30


Annual Market Values




Asset Allocation June 30, 2014
