MARTIN LUTHER KING, JR. ACTIVITIES

MLK Day began with "Operation Safe Sidewalks" at 10:00 a.m. on January 20 organized through the CLACS (Center for Leadership, Activities, and Career Services) Office. Students reported to the University Center dressed for the weather, divided into groups and cleaned up city sidewalks by shoveling, picking up debris, and salting to ensure that our residents in the community are safe. Shovels and salt were provided.

The Office of Multicultural Student Services' annual MLK Freedom March took place on Monday, January 20 as well beginning at 4:00 p.m. The march commemorates the life and legacy of Dr. King on this day. The march began and concluded at the University Center Rankin Atrium. Following the Freedom March, a Student Tribute Program featured a special talk and performance by Mike Ellison who is a multifaceted Executive Artist, musician, actor and producer. Ellison has released independent records and headlined

national tours, while registering acting credits spanning film, television and theater. Ellison's MLK presentation was a blend of culture, commentary, history, hip-hop, spoken word and storytelling. Each event had over 250 participants who join in the celebration to keep Dr. King's dream and legacy alive on the campus of Ferris State University. As always, this year's celebration was enjoyed by students, faculty, staff and the local celebration.



UNIVERSITY CLOSING OR CANCELLING OF CLASSES POLICY

Ferris State University is a multi-campus institution and therefore this policy has been written in an attempt to contemplate situations in Big Rapids, Grand Rapids, and across the State. The Big Rapids campus is a residential student campus and accordingly will almost always be open to students residing on campus. The University will cancel classes only under the most severe weather or other conditions. If the decision is made to cancel classes, periodic announcements will be made on area radio and television stations, the University's website, other pre-established communication venues or students may call the Ferris Information Line at 231-591-5602.

Since a large number of students live on the Big Rapids campus and these students are dependent upon Dining Services, Telecommunications, Residential Life, Physical Plant and Public Safety, it is the University's intent to provide these services and, in addition, make every effort possible to keep the Library, Convocation Center/Wink Arena, Sports Complex, Racquet Facility, Student Recreation Center and the University Center open.

Since our community college locations across the state have several unique circumstances related to weather conditions, the Extended and International Operations Dean or his/her designee will have the responsibility for cancelling classes when necessary, at each respective location.

Decisions on weather related delays and closures at Kendall College of Art and Design are made by the President of KCAD or his/her designee. These decisions to cancel classes at KCAD are often made to follow decisions made by Grand Rapids Community college. In those cases, the class cancellation would also apply to the FSU-GR classes held at GRCC.

The Pharmacy program in Grand Rapids will have the same delays or closures as the EIO programs offered at GRCC.
