

# FERRIS STATE CLUB SPORT CODE OF CONDUCT

As a participant in the Ferris State Club Sports Program, you are expected to conduct yourself in a manner that will reflect positively upon you, the Club of which you are a member, the University Recreation Department and Ferris State University. All Clubs and its members are expected to abide by the following:

- Ferris State University requires all Registered Student Organizations (RSO) to adhere to all University policies, RSO handbook policies, and local, state, and federal laws.
- All Club members must abide by the Code of Student Community Standards.
- All Club members will conduct themselves accordingly and responsibly at any and all Club-sponsored activities. These include, but are not limited to, home and away events, practices, fundraisers, and socials.
- All Club members understand that their actions whether as an individual, group or entire Club impact the whole Club, the Club Sports Program, the University Recreation Department, and Ferris State University.
- All Club members will show respect to all teammates, opponents, referees, officials, spectators, staff, and employees.
- All Club members will abide by the University Recreation policies and procedures. These include the policies and procedures outlined in the Club Sports Handbook and the University Recreation Facilities policies and procedures.
- All Club members will abide by the NO TOLERANCE RULE regarding hazing.
- All Club members must understand that their actions whether as an individual, group, or entire Club may affect an individual or Club's ability to receive any of the privileges and/or funding afforded to Club Sports.

I understand that if I do not adhere to the above guidelines than the following consequences may occur. The severity of the offense will determine whether other entities become involved. I understand that University Recreation reserves the right to inform campus officials of infractions, and that those decisions are independent of any decisions made by the University Recreation Department and the Club Sports Program.

## Individual Violations

- Probationary period set forth by the A.D. of Intramurals and Club Sports.
- Suspension from Club Sports activity for a duration of time based upon the severity of the offense.
- Removal from the Club Sports Program.
- Referral to the Office of Student Conduct for disciplinary action.

## Team Violations

- Probationary period set forth by the A.D. of Intramurals and Club Sports.
- Forfeiture of a number of competitions based on the severity of the offense.
- Forfeiture of activities, privileges and/or services provided to the team (including facilities and finances).
- Suspension from the Club Sports Program.
